

ORDINANCE NO. 19-32

AN ORDINANCE REPEALING ORDINANCE NO. 17-112
(APPROVING THE SALARY OF THE CITY AUDITOR) AND
PRESCRIBING THE SALARY OF THE CITY AUDITOR

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
COLORADO SPRINGS:

Section 1. In accordance with City Charter § 3-10(e) and City Code § 1.2.203, the annual salary of the City Auditor, shall be prescribed by ordinance.

Section 2. Ordinance No. 17-112 (approving the salary of the City Auditor) is repealed and the salary of the City Auditor is prescribed at \$171,797.00, together with applicable benefits, effective December 30, 2018.

Section 3. This ordinance supersedes all prior ordinances that are inconsistent herewith to the extent such prescribed the salary of the City Auditor, including Ordinance Nos. 13-59, 13-76, 14-33, 17-11, and 17-112.

Section 4. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by charter.

Section 5. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.

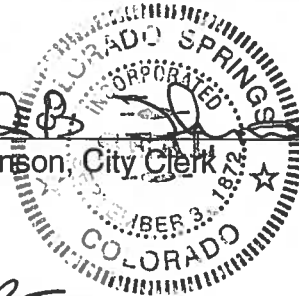
