# 1. Call to Order

Citizen Charles Barber spoke about the importance of young people considering and respecting the contributions of individuals to society.

Citizen Gary Derbenwick representing the Emerald Heights subdivision, voiced concern about changes the Planning Department has made to requirements in the Erindale neighborhood.

Citizen Deborah Stout-Meininger spoke about ethical concerns and City spending.

Citizen Keesha Jackson requested increased spending on public transportation.

Citizen Allen Beauchamp thanked Council for the resolution designating June as Bike Month, invited everyone to the Mayor's Bike Ride and to participate in Bike to Work Day and thanked those in office in 1980 for implementing the bicycle tax fund.

Citizen Walter Lawson spoke about the Cable Franchise Agreement renewal process requesting the process be reconsidered to allow enough time for citizen input to take place. Councilmember Knight explained the agreement expiration date transfers the agreement to a month-to-month continuation allowing for additional time to finalize the agreement if needed. Councilmember Knight also reminded everyone that the agreement can only address cable service, not internet and phone. David Andrews, Legislative Counsel, stated the City Attorney's Office will assure the process moves forward. Ms. Gonzalez will work with the Chief of Staff on a timeline.

Citizen Dave Hawkins requested a pay increase for Councilmembers.

Citizen Susan Davies, Executive Director of the Trails and Open Space Coalition, spoke about the economic benefits of sporting activities to communities.

Citizen Vincent Braughton addressed Council regarding his personal safety issues and economic issues that he states he has suffered under Mayor Bach's administration. Mr. Broughton presented documents to Council for their review.

Citizen Kyleah Daily commented on the positive change of the

**9.A.** <u>15-00277</u> A Resolution Approving an Amended and Restated Intergovernmental Agreement Between the City of Colorado Springs and Colorado Centre Metropolitan District Providing for Water Distribution and Wastewater Collection, Treatment, and Disposal

Brett Schueler, System Extensions Manager with CSU, was available to answer questions, there were no questions.

Attorney Steve Mulliken, representing Bradley Heights, spoke in support of the agreement.

Motion by Councilmember Pico, seconded by Councilmember Strand, that the Resolution approving and authorizing the execution of the Amended and Restated Intergovernmental Agreement between the City of Colorado Springs, Colorado, and the Colorado Centre Metropolitan District for Water Distribution and Wastewater Collection, Treatment, and Disposal be adopted. The motion passed by a vote of 8-1-0.

- 13. Added Item Agenda
  - **13.A.** <u>15-00331</u> Issuance of formal ethics charges or dismissal of ethics complaint pursuant to Independent Ethics Commission case 2015-01

Council President Bennett requested Councilmember Collins recuse herself from this agenda item. Councilmember Collins denied the request to recuse herself, so Council President Bennett recused her.

Councilmember Collins made a statement opposing the Independent Ethics Commission report and defending her actions as a member of Council representing her district.

Councilmember King read a statement about the IEC findings/process and provided a copy to Councilmembers.

Council discussed the process and potential actions and consequences of action taken by Council with Suzanne Dugan, independent counsel, hired to represent and advise Council on this topic.

Motion by Councilmember King, seconded by Councilmember Strand, that City Council issue three ethics charges as recommended by the Independent Ethics

Commission. These are:

• City Code 1.3.106, Paragraph (G) that provides "no covered person shall tolerate waste, fraud, abuse and corruption in government or in any of its business, operations or services."

• City Code 1.3.106, Paragraph (H) that provides "no covered person shall engage in any actions that may create, or do create, the appearance that they are violating the law or ethical standards."

• City Code 1.3.106, Paragraph (I) that provides "no covered person shall engage in any activity that may create, or does create, the appearance of impropriety."

Futhermore, City Council, in issuing formal ethics charges, is not making findings that the violations occurred. If this motion is approved, then Councilmember Collins may request an evidentiary hearing. If she makes that request, City Council can serve as the hearing body or appoint a hearing officer to conduct the proceedings. The motion passed by a vote of 8-0-1.

Council President Bennett requested Ms. Dugan prepare a letter to be delivered to Councilmember Collins within the next five days regarding the issuance of charges as recommended by the IEC findings.
