

ORDINANCE NO. 18-29

AN ORDINANCE AMENDING ORDINANCE NO. 17-116  
(2018 APPROPRIATION ORDINANCE) FOR A  
SUPPLEMENTAL APPROPRIATION TO THE GENERAL  
FUND IN THE AMOUNT OF \$346,506 FOR THE  
TUTT/COWPOKE STORMWATER PROJECT

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
COLORADO SPRINGS:

Section 1. That Ordinance No. 17-116 is hereby amended by increasing the revenue and expenditure appropriations of the General Fund in the amount of \$346,506 for the Tutt/Cowpoke Stormwater Project 9370055. The source of funds is the Tutt bridge surcharge fees currently held in escrow.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.




