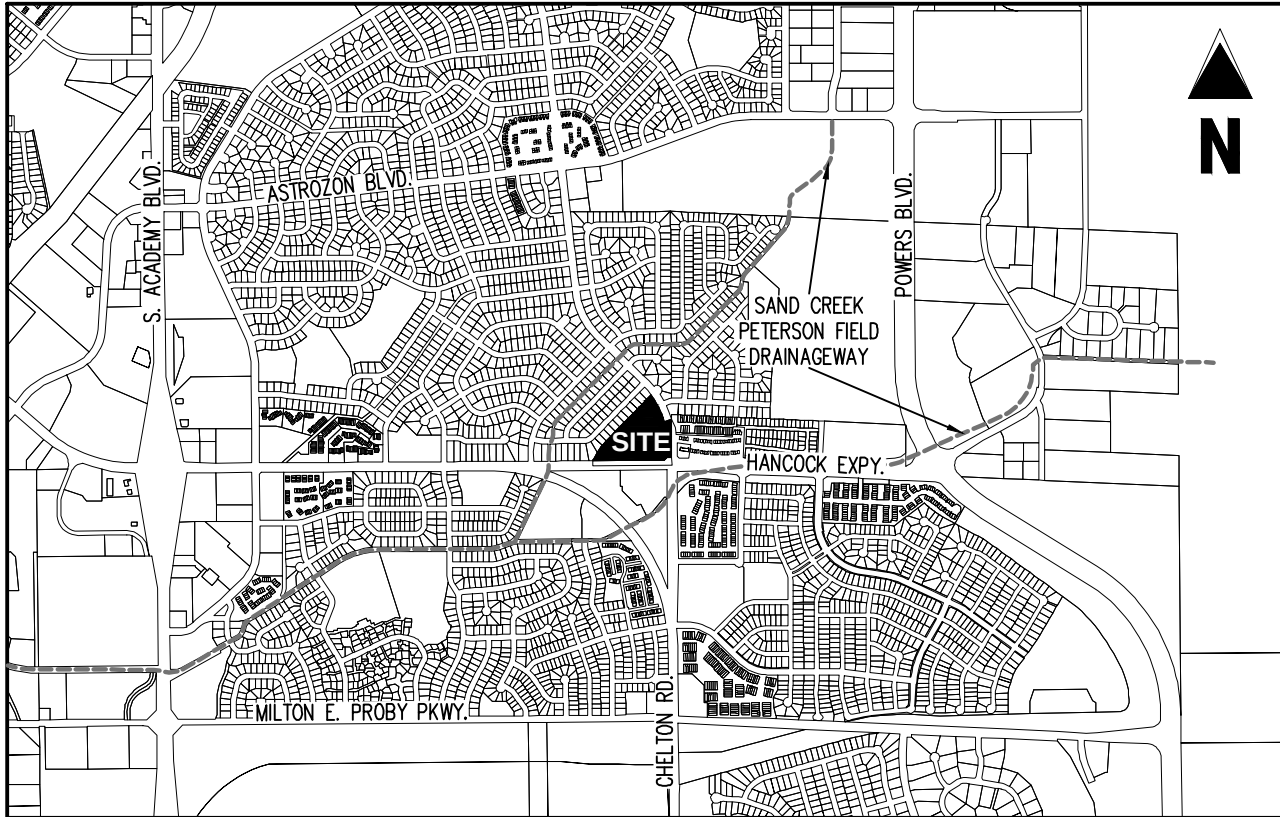


DAKOTA CROSSING

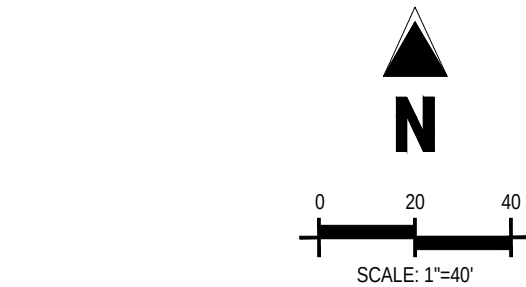

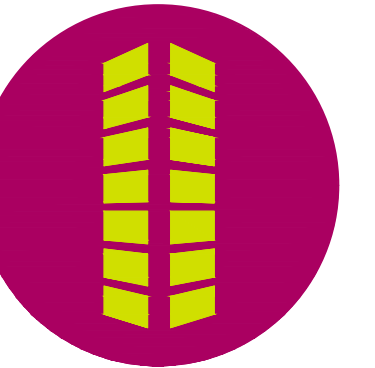
