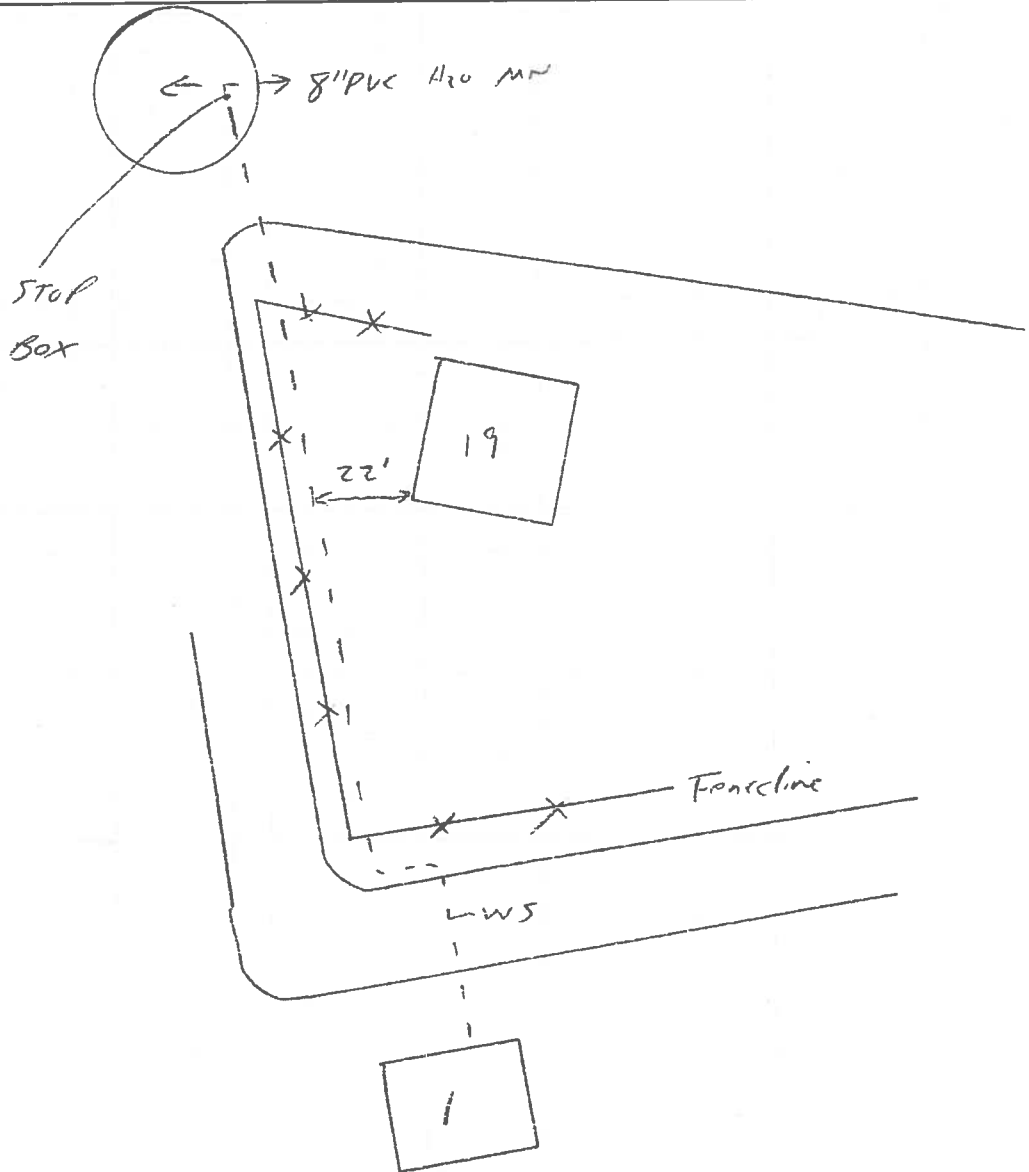

**Caution Dig Alert: You are digging in a high risk zone!**

Your dig area contains high profile underground facilities. To avoid injury and/or damage you must call (719) 448-4800 and press "1" to speak with a Springs Utilities representative before beginning any excavation. 24 hours notice is required.



**READ BEFORE YOU DIG:**

- Colorado Springs Utilities locate marks will be valid for 30 calendar days from the day marked, provided the marks are still visible. The excavator is responsible for maintaining the locate marks for the entire excavation period.
  - DO NOT DIG IF NO MARKS ARE FOUND!** Call UNCC at 811 for re-marks.
  - This locate sheet must be retained by the excavator on site at all times.
  - The utility facility is located within 18" (eighteen inches) of either side of marks, flags, or whiskers. If not found, Colorado Springs Utilities must be notified at 668-7205 to help determine the correct location.
  - **Private utilities** may exist in your dig area. Colorado Springs Utilities is not responsible for locating private utilities. Please call the Utility Notification Center of Colorado (UNCC) for a list of private locate companies in your area. **For sewer service measurements call 668-442**
  - **All utilities must be exposed and identified** by manual excavation for proper width and depth before crossing over or under. Exposure must be where the excavation is going to cross the utility.
  - **Hand Dig** within a 5 foot radius of all Colorado Springs Utilities surface facilities.
- ALL DAMAGES, EVEN MINOR DAMAGES SUCH AS NICKS, SCRATCHES AND SCRAPES, MUST BE REPORTED IMMEDIATELY!** Report 24 hours a day, 7 days a week to UNCC at 811 and Colorado Springs Utilities at 448-4800 for direct response to the damage.
- Excavations that are over 600' will be classified as an extended job and a time schedule should be established with Colorado Springs Utilities before excavation begins.
  - **Sewer mains** are marked at manholes only.
