> Councilmember Pico stated he not opposed to most of the content of the Ordinance and is in favor of conservation measures, but is concerned about the three-day per week restrictive watering and the Ordinance should identify what will be enforced at every level. He stated the City has one of the best water conservation programs in the state and if a half percent of revenue is cut on conservation, it will not be made up for in raising rates.

Councilmember Gaebler stated she supports this item because if the right kinds of plants are planted, three days of watering per week is adequate and the City should be working towards that goal. She stated the City should be leaders in conservation efforts for the area.
