5.B. [21-500](#) Continued overview of the planned uses of the American Rescue Plan Act (ARPA) direct allocation to the City of Colorado Springs

Charae McDaniel, Chief Financial Officer, gave an overview of the planned uses of the American Rescue Plan Act (ARPA) direct allocation to the City. She provided a summary of the ARPA, local fiscal recovery funds, details of the planned use of funds, COVID-19 funding website, and the 2021 Recovery Plan Report.

President Pro Tem Skorman asked how the funding will be dispersed for small businesses. Ms. McDaniel stated it will be distributed through Survive and Thrive and the Small Business Development Center (SBDC).

Councilmember Helms asked if the golf courses will be able to support their operational expenses in the future when this funding is not available. Ms. McDaniel confirmed they would.

Councilmember Henjum requested additional information regarding the funding towards the City Auditorium. Ms. McDaniel stated this money would be the City's contribution to the rehab and renovation of the building associated with the Colorado Springs Conservatory proposal for the art and event space. Jeff Greene, Chief of Staff, stated Bob Cope, Economic Development Manager, will provide an update regarding the progress of the Colorado Springs Conservatory proposal.

Councilmember Henjum asked what the official process is to obligate the funding from the federal government. Ms. McDaniel explained the reporting requirements of how the funds are spent and the process of how subrecipients are utilized.

Councilmember Murray stated he does not support the amount of money going toward the irrigation of golf courses when there are other critical infrastructures which the money could be used for. Ms. McDaniel stated the golf courses do qualify as governmental services.

Councilmember Murray requested additional funding be allocated to Crisis Response Teams (CRT). Ms. McDaniel stated CRT will be funded through the 2022 Budget process and the City wanted ARPA funds to be used toward one-time expenses.

Councilmember Avila stated she supports the funding of the outdated golf course irrigation systems because the community needs this type of outdoor recreation which is not privately owned.

Councilmember Donelson asked if the City will be dedicating money to the City Auditorium outside of the Colorado Springs Conservatory's proposal. Ms. McDaniel stated it has allocated a little money in the past for maintenance, but there are no other plans in place regarding allocation. Councilmember Donelson asked if there is anything be done to get the City Auditorium in working condition prior to the Colorado Springs Conservatory's plan being funded. Steve Posey, Community Development Division Manager, stated the procedure for returning the City Auditorium to pre-pandemic condition has been completed, but it is reserve in case it is needed as an additional COVID-19 isolation shelter.

Councilmember Donelson asked if the current Senior Center property (Golf Acres) could be utilized as senior housing. Mr. Posey stated there is currently an existing senior income-restricted apartment complex in the Golf Acres site which is owned by Silver Key which will remain and some of the development models do include an affordable housing component.

Councilmember Donelson asked why the City would fund \$3.5M to the Colorado Springs Utilities (CSU) replacement of aging water main project. Ms. McDaniel stated so CSU could use their money to fund other projects. Councilmember Williams stated it is also a benefit to CSU rate payers.

Councilmember Donelson requested additional information regarding the Family Success Center. Ms. McDaniel stated it provides services to the residents in the southeast and Pikes Peak United Way is the coordinating entity.

Councilmember Murray asked much funding is going to the Cheyenne Mountain Zoo, Garden of the Gods Park, and the Pikes Peak Summit House. Ms. McDaniel stated there is nothing specifically designated at this time and the Cheyenne Mountain Zoo would be eligible to apply under the economic development and recovery funds.

Steve Posey, Community Development Division Manager, gave an overview of the American Rescue Plan Act (ARPA) funding made available to the City for addressing homelessness and affordable housing. He identified what is included in the bill, \$11.3M for emergency rental assistance, \$5.7M homeless assistance and support services, applications received in El Paso County, HOME program funds, how the funds will be accessed, allowable uses, and collaborating agencies.

President Strand asked how a person could receive rental assistance. Mr. Posey stated they would need to qualify as a low-income household and contact the 2-1-1 program to apply. President Strand asked if the funding goes to the applicant or the apartment owner. Mr. Posey stated it can be done either way because both are engaged in the application process.

President Pro Tem Skorman asked how much of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) funding is remaining. Mr. Posey stated approximately \$10.5M plus the additional award of \$11.3M is left.

Councilmember Henjum requested the breakdown of assistance based on loss of job versus the increase of rent. Mr. Posey stated one hundred percent of this assistance is going to tenants and landlords impacted by COVID-19.

Susan Edmondson, President and CEO, Downtown Partnership of Colorado Springs, gave an update of the economic and performance indicators of the Downtown Partnership of Colorado Springs. She gave an

overview of the total investments at the start of 2021, investment growth since 2013, visits trend, gross sales of the Downtown Development Authority (DDA), new storefront businesses, residential, and development, current and future focus, and International Downtown Association Awards.

President Pro Tem Skorman asked how many new businesses are food or beverage-related establishments. Ms. Edmondson stated approximately seventy percent.

President Strand asked how many businesses closed. Ms. Edmondson stated in 2020, there were twenty to twenty-one new openings and just slightly less than that in closings.

Councilmember Henjum requested an update of the upgrade to the public transit station. Jeff Greene, Chief of Staff, stated Craig Blewitt, Director, Transit Services, will provide an update.

President Pro Tem Skorman stated there are no public restrooms downtown which is a burden to the small businesses. Ms. Edmondson stated it is a high priority and need.

Steve Posey, Community Development Division Manager, presented the Ordinance to issue \$11.2M in 2021A and \$4.758M in 2021B multi-family housing revenue bonds to finance the Village at Solid Rock, a 77-unit

multi-family affordable housing project. He provided a background of the preliminary inducement Resolution, Private Activity Bonds (PAB) allocations, site location, and project description.

President Strand asked where this project was located. Mr. Posey stated it is located in the southeast on Arlington Drive to the east of Circle Drive and south of Fountain Boulevard.

Councilmember Avila stated she and the community are very supportive of this development.

Councilmember Donelson asked if there has been any community response from the public notice. Mr. Posey stated there has not.

Councilmember Helms expressed appreciation for the project.
