

ORDINANCE NO. 22 - 52

AN ORDINANCE AMENDING ORDINANCE NO. 21-112 (2022 BUDGET APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE GENERAL FUND IN THE AMOUNT OF \$2,700,000 FOR ESTABLISHING THE KEEP IT CLEAN COS PROGRAM WHICH WILL PROACTIVELY AIM TO REDUCE LITTER AND IMPROVE THE APPEARANCE OF PUBLIC RIGHTS-OF-WAY

WHEREAS, The Keep It Clean COS program is a comprehensive initiative aimed at reducing litter and improving the appearance of our city. Keep It Clean COS will focus on reducing litter on public medians, priority corridors, arterials/collectors and residential rights-of-way; and

WHEREAS, the total funding requirement of this program in 2022 is \$2,700,000 which will cover the purchase of one-time equipment, along with the staffing and operating needs for the program.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:


Section 1. Ordinance No. 21-112 is hereby amended by increasing the General Fund expenditure appropriation in the amount of \$2,700,000 for equipment, positions and operating to establish the Keep It Clean COS program. The source of funds is the General Fund available fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
