

ORDINANCE NO. 17-104

AN ORDINANCE AMENDING ORDINANCE NO. 16-116 (2017 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE FOLLOWING FEDERAL ENTITLEMENT GRANTS: COMMUNITY DEVELOPMENT BLOCK GRANT IN THE AMOUNT OF \$139,970, EMERGENCY SOLUTIONS GRANT IN THE AMOUNT OF \$9,506, AND THE HOME INVESTEMENT PARTNERSHIPS PROGRAM IN THE AMOUNT OF \$35,208

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 16-116 is hereby amended by increasing the revenue and expenditure appropriations for the Community Development Block Grant in the amount of \$139,970. The source of funds consists of grant revenue from U.S. Department of Housing and Urban Development.

Section 2. That Ordinance No. 16-116 is hereby amended by increasing the revenue and expenditure appropriations for the Emergency Solutions Grant in the amount of \$9,506. The source of funds consists of grant revenue from U.S. Department of Housing and Urban Development.


Section 3. That Ordinance No. 16-116 is hereby amended by increasing the revenue and expenditure appropriations for the HOME Investment Partnerships Program in the amount of \$35,208. The source of funds consists of grant revenue from U.S. Department of Housing and Urban Development.

Section 4. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 5. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.


