

ORDINANCE NO. 16-120

AN ORDINANCE AMENDING ORDINANCE NO. 07-113  
PERTAINING TO THE PUBLIC ART COMMISSION OF THE  
PIKES PEAK REGION

WHEREAS, City Council adopted Ordinance No. 07-113 pertaining to the Public Art Commission of the Pikes Peak Region and setting parameters for members on such Commission; and

WHEREAS, by Ordinance No. 09-94 and Ordinance No. 14-18, City Council amended Ordinance No. 07-113; and

WHEREAS, City Council intends to further amend Ordinance No. 07-113 as stated herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
COLORADO SPRINGS:

Section 1. Ordinance No. 07-113 is hereby amended to read as follows:

Section 2. The PACPPR shall consist of eleven (11) regular members and two (2) ex officio members, representing a cross-section of the community as follows:

One (1) representative from the Pikes Peak Arts Council;

One (1) representative from the Southern Colorado Chapter of the American Institute of Architects;

One (1) representative from the Fine Arts Center;

Three (3) artists from the community;

One (1) higher education arts professional; and

Four (4) citizens at-large.

One (1) City Councilmember and one (1) member of the El Paso County Board of Commissioners shall be

appointed to serve as voting ex officio members of the PACPPR.

**All members of the PACPPR must be residents of El Paso County, Colorado, and a majority of the members of the PACPPR must be residents of the City of Colorado Springs, Colorado.**

Section 6. ~~Seven~~ **Six (6) regular** members shall constitute a quorum.


