

ORDINANCE NO. 16-50

AN ORDINANCE AMENDING ORDINANCE NO. 15-86 (2016 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE CITY-FUNDED CIP FUND IN THE AMOUNT OF \$356,250 FOR THE CONSTRUCTION OF SEVERAL TRAFFIC SIGNAL PROJECTS

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Ordinance No. 15-86 is hereby amended by increasing the revenue and expenditure appropriations in the amount of \$356,250 to the City-Funded CIP Fund, account 202-3300-9330004. The source of funds is the Deferred Revenue account number 23004-001 in the amount of \$356,250.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.





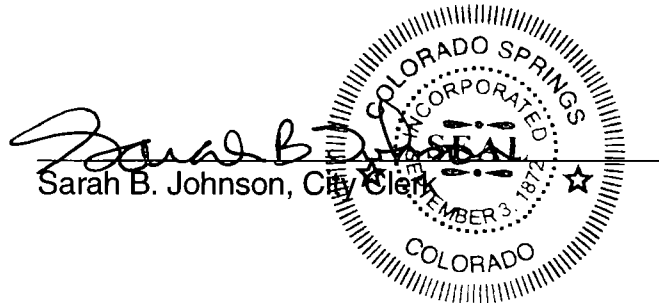
