RESOLUTION NO. 2025-1

RECOMMENDATION TO THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF EL PASO AND THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS REGARDING PIKES PEAK REGIONAL BUILDING DEPARTMENT'S BOARD AND COMMITTEE MEMBER APPOINTMENTS

Adopted on the 27th day of February, 2025.

WHEREAS, Pikes Peak Regional Building Department is responsible for the plan review, permitting, and inspection of all construction activity within the unincorporated areas of El Paso County, as well as the participating incorporated municipalities within the County. These currently include the Cities of Colorado Springs, Fountain and Manitou Springs and the Towns of Green Mountain Falls, Monument and Palmer Lake, as well as the City of Woodland Park (individually, the "Jurisdiction", or collectively, the "Jurisdictions").

WHEREAS, the Jurisdictions adopt a building code every six (6) years after Pikes Peak Regional Building Department reviews new model codes, as developed and published, and recommends a code for adoption to the Jurisdictions. The current code in effect for building construction or the installation of systems or equipment for all Jurisdictions, as adopted by them, is the Pikes Peak Regional Building Code, 2023 Edition. This Code provides for the administration of Pikes Peak Regional Building Department, licensing and registration of contractors, issuing of permits, conducting inspections, and enforcement of adopted model codes. Sections of this Code are denoted by the prefix "RBC" to differentiate this Code from other codes.

WHEREAS, Pikes Peak Regional Building Department is governed by a Regional Building Commission, which is a three-member governing body consisting of a member of the Board of County Commissioners of El Paso County, a member of the City Council of the City of Colorado Springs, and a representative of one of the five (5) suburban jurisdictions.

WHEREAS, in order to carry out and accomplish the provisions and objectives of the Code, historically, the administrative section of the Code has established a Board of Review, advisory committees to the Board of Review, and a Board of Appeals.

WHEREAS, in accordance with Section RBC111.1, Board of Review Established, the Board of Review is comprised of five (5) members, as follows: a registered engineer (structural,

electrical, or mechanical); an architect licensed by the State of Colorado; a Building Contractor A or B (commercial work); a Building Contractor A, B, or C (home builder); and a citizen at large experienced in building construction.

WHEREAS, in accordance with Section RBC111.2, Authority and Responsibility of Board of Review, the Board of Review has authority to propose rules, regulations, and standards as may be necessary to accomplish the purposes and objectives of the Code; grant and revoke licenses and registrations provided for in the Code; and reasonably interpret the Code, including the authority to grant minor variances from the provisions of the Code.

WHEREAS, in accordance with Section RBC112.1.4, Board of Appeals, the Board of Appeals is comprised of the five (5) members of the Board of Review.

WHEREAS, in accordance with Section RBC111.3, Advisory Committees; Purpose, advisory committees are established as advisory to the Board of Review to review appeals with power and authority to interpret and recommend minor variances from the Code and to examine all applicants for licenses and registrations.

WHEREAS, in accordance with Section RBC111.4, Advisory Committees; Composition and Functions, the Technical Committee is comprised of seven (7) members, as follows: an architect licensed by the State of Colorado; a professional engineer licensed by the State of Colorado (civil – structural); a Building Contractor A, B, or C; a Mechanical Contractor A; and the Licensing Committee is comprised of seven (7) members, as follows: an architect licensed by the State of Colorado; a professional engineer licensed by the State of Colorado (mechanical) or a Mechanical Contractor A; a Building Contractor A; a contractor (building, mechanical, plumbing, or electrical); a Building Contractor C; an officer of a financial institution; and a citizen at large.

WHEREAS, in accordance with Section RBC111.5.1 of the Code, Appointments, appointments to the Board of Review and advisory committees are made by the Board of County Commissioners of El Paso County in conjunction with the City Council of the City of Colorado Springs, acting as individual bodies, but in agreement.

WHEREAS, in accordance with Section RBC111.5.2, Terms, a term of services on the Board of Review and advisory committees is for two (2) consecutive three (3)-year terms unless to fill a vacancy. After the two (2) consecutive terms are completed, members shall serve as an alternate member for an additional two (2) years. In the event that a quorum cannot be established, an alternate member may be asked to attend prior to the scheduled meeting.

WHEREAS, historically, the Board of County Commissioners of El Paso County and the City Council of the City of Colorado Springs have divided appointment responsibilities, as follows:

- For the Board of Review, the Board of County Commissioners of El Paso County has appointed the registered engineer (structural, electrical, or mechanical) and the Building Contractor A or B (commercial work), and the City Council of the City of Colorado Springs has appointed the architect licensed by the State of Colorado and the Building Contractor A, B, or C (home builder). The Board of County

Commissioners of El Paso County and the City Council of the City of Colorado Springs have appointed the citizen at large experienced in building construction jointly.

- For the Technical Committee, the Board of County Commissioners of El Paso County has appointed the Mechanical Contractor A and the Master Plumber licensed by the State of Colorado, and the City Council of the City of Colorado Springs has appointed the architect licensed by the State of Colorado; the professional engineer licensed by the State of Colorado; the Building Contractor A, B, or C; the Electrical Contractor licensed by the State of Colorado; and the Building Contractor D, E, or subcontractor.
- For the Licensing Committee, the Board of County Commissioners of El Paso County has appointed the architect licensed by the State of Colorado; the professional engineer licensed by the State of Colorado (mechanical) or Mechanical Contractor A; the building, mechanical, plumbing, or electrical contractor; and the Building Contractor C, and the City Council of the City of Colorado Springs has appointed the Building Contractor A. The Board of County Commissioners of El Paso County and the City Council of the City of Colorado Springs have appointed the officer of a financial institution and the citizen at large jointly.

WHEREAS, because the Regional Building Commission of Pikes Peak Regional Building Department is a commission of three appointments consisting of a member of the Board of County Commissioners of El Paso County, a member of the City Council of the City of Colorado Springs, and a representative of one of the five (5) suburban jurisdictions. As a result of CRS 24-6-402(2)(b), all meetings of a quorum of the Regional Building Commission (i.e., 2 commissioners), at which any public business is discussed, are declared to be public meetings open to the public at all times. As a result, historically, all joint board and committee member appointments have been considered, reviewed, approved, and thereafter recommended by the Board of County Commissioners of El Paso County to the City Council of the City of Colorado Springs for consideration, review, and approval.

WHEREAS, the Regional Building Commission wishes to document the historical Pikes Peak Regional Building Department's board and committee member appointments and recommend to the Board of County Commissioners of El Paso County and the City Council of the City of Colorado Springs to adopt, formally, if needed, and maintain the historical precedent of the process of Pikes Peak Regional Building Department's board and committee member appointments.

NOW, THEREFORE, BE IT RESOLVED, the Regional Building Commission of Pikes Peak Regional Building Department declares it to be in the best interest of the Jurisdictions to continue the historical precedent of the process of Pikes Peak Regional Building Department's board and committee member appointments, as described above and incorporated herein by reference.

BE IT FURTHER RESOLVED, that, the Regional Building Commission of Pikes Peak Regional Building Department recommends to the Board of County Commissioners of El Paso County and the City Council of the City of Colorado Springs to adopt, formally, if needed, and


maintain the historical precedent of the process of Pikes Peak Regional Building Department's board and committee member appointments.

BE IT FURTHER RESOLVED by the Regional Building Commission of Pikes Peak Regional Building Department that Carrie Geitner, duly elected, qualified member and Chair of the Regional Building Commission, or Brian Risley, duly elected, qualified member and Vice-Chair of the Regional Building Commission, be and is hereby appointed and authorized on behalf of the Regional Building Commission to execute this Resolution and any other necessary documents on behalf of the Regional Building Commission in order to complete implementation of the recommendation herein.


