Rich and Hannah,

Rich, again thank you for cc'ing me in on this given my past experiences and concerns arising from mandatory evacuations. And while my former home was subject to 3 mandatory storm related evacuations, I never was able to participate due to road congestion....where flooding reduced escape routes resulting in massive congestion. Since I have moved back to the Springs, we have seen quite a few fires, some of them notably in the national news. The tragic fires and loss of life in California (Paradise, CA) are well known to me and highlights the need to avoid overloading escape routes....a single accident along Thunder Mountain Ave. in the midst of a fire evacuation is the prelude to disaster.

More importantly, emergency vehicle access into our neighborhood to address fires while people are leaving over highly congested and limited exit streets is another recipe for needless loss of life. Ms. Van Nimwegen, we might think when an evac order is given people will act rationally, and leave a car or two behind but being their second most costly assets, families with 4 people and 3 cars take ALL THREE CARS leading to worst case scenarios that are clearly not being addressed in these planning stages.

It will lead to loss of life.
A preventable loss of life.

When the main exit and entrance for emergency vehicles for a large development narrows to one lane each.....except for a dangerous alternate going through a crowded neighborhood, then the safety of the current and future residents is being placed at risk for lack of public action in creating the necessary infrastructure.

Its public record that the traffic manager acknowledges a traffic issue due to the high school.....but we have seen an additional (elementary) school added on the route and the approval of more homes on the same limited routes.

Please let us know the process to highlight our communities' concerns.....more road access is needed now, not before adding more homes to complicate what is already seen as a safety issue. The only way to guarantee emergency vehicle access in the event of a regional fire driven evacuation is adding more ingress and egress lanes from the east or north.

Hi Rich, it appears as though you spelled my name incorrectly in the email from yesterday, so it did not reach me. However, I did receive this message with that message below it.

As I have described, when a decision is rendered, any member of the public may appeal that decision. Up to that point, all comments are made part of the public record and would become a part of the appeal record if one is filed. At this time, all written objections to the development are being logged for the record.

I plan to continue to work with the Traffic Engineering Department to try to find a solution to the existing traffic issue, though, I know they are very aware. As Todd mentions in your emails, we have also been in communication with the school district to try to alternate the school's start time to remove the overlap between peak school traffic and peak commuter traffic. It is documented in the traffic report that an alternate start time would eliminate most, if not all, the issues experienced by morning commuters. The school district communicated to us that our request was declined, but I would encourage you to add your voice.

I will continue to keep you updated on the status of the development plan and plat. Yesterday, I emailed that the second submittal was received and redistributed to review agencies. From here, either another review letter will be issued or a decision will be rendered if all review agency comments are addressed.

Mr. Sevcik – The traffic study did not include the intersection to the entrance of the high school. We did not include this intersection because the congestion is caused by a high volume of vehicles trying to access the school in a short period of time. In addition, the peak of school traffic overlaps with the peak of commuter traffic. Therefore, we believe that congestion of Thunder Mountain will not be solved with more lanes or a change in traffic control but could be reduced if the school changed to a later start time. Another high school in the city switched to a later start time and this largely resolved the daily congestion issue around the school. We have asked school district 20 if they would consider a later start time and they declined to do so. We have a good working relationship with District 20 and will continue to work with the district as traffic patterns change over time.

Congestion around high schools is common around most high schools in the city. We at the City work with the districts to reduce congestion by suggesting changes in their drop off/pick up patterns or times. We also provide recommendations for adding additional on-site infrastructure to accommodate vehicle queuing. However, in the end school districts are autonomous agencies that are free to operate their schools as they deem best.

I am sorry I can't be of more help but there is no easy fix to addressing school related congestion.

The traffic study did NOT evaluate the intersection at the entrance driveway to the high school. I suspect that this entrance is not officially considered as an intersection? However that entrance is by far the worst congestion. On Thunder Mountain Ave the northbound lane (which is the exit from our development) has a stop sign and is only one lane for exiting. The southbound traffic on Thunder has the right of way, no stop sign, to make a left hand turn into the high school driveway. So when school is open in the morning and afternoon, the incoming school traffic completely 'blocks' the northbound traffic on Thunder Mountain.

The current situation is already horrible! Kettle Creek North added traffic will further aggravate this unacceptable situation.

I would like to APPEAL the decision to proceed with Kettle Creek North development.

I am the lead of an ad hoc committee for the North Fork HOA.

> This proposal will not be required to go before the City Council unless appealed. The rezoning was approved by the City Council in mid 2020, and the application currently under review is the development plan which is decided on by staff in the Planning Department. At this time, that decision has not been rendered. A resubmittal with revised plans according to the first review comments has not been received. I will notify the group when the resubmittal is received. The only instance in which this application will go to a public hearing is if the decision on the development plan is appealed. It would first be heard by the City Planning Commission and then, if appealed a second time, would be heard by the City Council. The appeal cannot be filed until a decision is rendered, and must be done within 10-days of that decision.

Hey Rich,

The response they gave me to your previous email was, roadways don't use the Level of Service (LOS) metric, only intersections. Roads use Average Daily Trips (ADT) which is then compared to the capacity of the road classification. Thunder Mountain was originally designated as a minor arterial road, with a capacity of 25,000 vehicles per day, when the master plan was approved. As development began, the road was constructed to collector road standards. Figure 4 illustrates an ADT of 6,370. These numbers assume full build-out of the North Fork subdivision which would include those townhomes.
