Doug Price, President and CEO, Colorado Springs Convention and Visitors Bureau (CVB), presented the 2017 third quarter Performance Measures report which reflected results through August 2017. Mr. Price stated Lodgers and Automobile Rental Tax (LART) collections revenue was up 14.9 percent from 2016. Mr. Price stated that trade shows had been revised down to forty shows for 2017 and that CVB website visits were down due to Google Travel Guide redirecting web traffic from the CVB website directly to the attraction's website.

Councilmember Murray requested specific examples where the Chamber of Commerce and EDC has assisted the CVB. Mr. Price said that from a business standpoint, the CVB is not directly involved in the site visits that the Chamber of Commerce and EDC participates in, but that the Chamber of Commerce and EDC does assist in getting businesses to travel to Colorado Springs.

Councilmember Strand asked for the cost of the consultant team for the tourism master plan. Mr. Price stated that \$125,000 is budgeted for the contract for the team of consultants.

Bob Sallee, Chairman, Board of Directors, National Space Science & Technology Institute (NSSTI), introduced the Board of Directors for the NSSTI and presented the mission, function, and outcome of the Pikes Peak Observatory. He identified several instruments and telescopes to be used at the observatory, their current status, the proposed observatory site, the four summit locations that were considered, and their goal to provide informal Science, Technology, Engineering, and Mathematics (STEM) education to visitors. Mr. Sallee stated the project supports the United States Forest Service goals.

Ronald Segal, PhD, Board of Directors NSSTI commented that the summit of Pikes Peak is a unique point on the planet for this observatory.

Councilmember Knight asked if there was any indication from the National Forest Service as to their standing regarding the observatory. Mr. Sallee said there has not been any opposition to the plan at this time.

Councilmember Strand asked if the cost was under \$2 million. Mr. Sallee said that the current cost is under \$2 million and is confident that when it is completed, it will be under \$3 million. Councilmember Strand asked if there were any funds in a capital campaign. Mr. Sallee said there is no capital campaign at this time because approval from the National Forest Service is required first.

Dave Leinweber, Owner of Angler's Covey and Chairman and Founder of the Pikes Peak Outdoor Recreation Alliance (PPORA), presented the fall 2017 update of the outdoor recreation economy. Mr. Leinweber identified the Outdoor Industry Association (OIA) members and stated that the Outdoor Retailers Show will bring 85,000 people to Denver this year resulting in a \$110 million economic impact. He explained that the outdoor recreation economy generates \$887 billion annually in consumer spending and 7.6 million jobs. Mr. Leinweber compared outdoor recreation to other

industries, identified their mission, the PPORA Board, Advisory Council, and the events and accomplishments they had achieved throughout the community.

President Pro Tem Gaebler asked if there were any staff from the City on the PPORA Board or committee. Mr. Leinweber said no, but that they have worked to keep Karen Palus, Director, Parks, Recreation & Cultural Services, informed and will pursue future involvement with the Parks, Recreation and Cultural Services Department.

Charae McDaniel, Chief Financial Officer, presented expediting the proposal to refinance the current Certificates of Participation (COP) for the lease of the United States Olympic Committee (USOC) building prior to the end of the year. Ms. McDaniel explained that the proposed federal tax reform changes that have been through the U.S. House of Representatives and Senate would impact the way municipalities are able to deal with these types of financial instruments. She said that if the refinancing is closed prior to the end of the year at the current interest rate would result in a ten to fifteen percent savings.

President Skorman asked what the total potential savings would be. Ms. McDaniel said it would be approximately \$4 million over the life of the COPs.

Carl Schueler, Planning Manager Comprehensive Planning, Planning and Community Development Department, provided a brief background of the current service plan of the Tuscan Foothills Village Metropolitan District.

Conrad Olmedo, Comprehensive Planner II, Planning and Community Development Department, presented a map identifying the property for the proposed inclusion and the proposed new district boundary.

President Pro Tem Gaebler asked regarding the exclusion of the multi-family infrastructure due to it not being a benefit to the district and asked if the City would provide the public infrastructure for that area if it is excluded from the district.

Ray O'Sullivan, representing the applicant, stated that all the public improvements for that apartment complex have already been completed and that the area does not require any additional district eligible public infrastructure improvements. President Pro Tem Gaebler asked if the district would benefit from the property tax collected from that property if it were not excluded. Mr. O'Sullivan explained that this district's maximum authorized debt was capped at \$1.1 million and imposing the mill levy on the apartment complex would not benefit the apartments.

Councilmember Knight commented that when the district was formed a year ago, this district had a large amount of hillside that was considered non-buildable and was going to be open space to the residents and questioned what had changed that now makes this area buildable. Mr. O'Sullivan said that Centennial Boulevard was improved which the district will be reimbursing the City for and that twenty-five of the fifty acres are now considered developable due to a geohazard report that was conducted. Mr. O'Sullivan also identified that only approximately three acres net were

going to be reduced from open space and parks.

Peter Carey, Chief of Police, presented the Intergovernmental Agreement (IGA) establishing the administration and governance of the Metro Vice, Narcotics and Intelligence (VNI) Division between the Colorado Springs Police Department (CSPD), El Paso County Sheriff's Office, Teller County Sheriff's Office, Fountain Police Department, Woodland Park Police Department, and the District Attorney's Office. Chief Carey identified that the agreement was previously completed as a Memorandum of

Understanding (MOU), but recent changes in financial responsibility when officers or deputies are involved in traffic accidents when driving VNI vehicles prompted the need for an IGA.

Councilmember Strand asked for more details for transitioning from MOU to IGA and why the financial burden was higher for the CSPD than the other departments. Chief Carey stated that an IGA is a higher level agreement for when financial payment needs to be transferred to other governmental agencies and that the IGA is financially equitable as it relates to the cases involved. Councilmember Strand requested the amount of cost for the CSPD that was included in the IGA. Chief Carey agreed to provide that information.

Frederick Stein, City Attorney, presented a chart to Council identifying what the differences were between the MOU and IGA. Mr. Stein stated that the IGA identifies more details regarding vehicle liability, funding, asset seizures, and reporting requirements as well as the IGA complies with House Bill 1313.

Peter Wysocki, Director Planning and Community Development, stated that the City's Historic Preservation Plan regarding historic structures within the City was developed in 1993 and has not been significantly updated since then. Mr. Wysocki stated that they have received \$55,000 in grants

and \$5,000 in local match to develop a new plan which will take approximately twelve months to complete.

President Pro Tem Gaebler asked who would be included as stakeholders. Mr. Wysocki stated that stakeholders would include residents from the Old North End, the Council of Neighbors and Organizations (CONO), Councilmembers, Historic Preservation Board members, residents from the Old West Side, and residents from Old Colorado City.

President Pro Tem Gaebler asked how the Historic Preservation Plan will compliment the Comprehensive Plan. Mr. Wysocki said that it will be incorporated into the Comprehensive Plan by reference.

Councilmember Knight asked if they could include Colorado Springs Utilities as a stakeholder. Mr. Wysocki agreed to keep them involved.
