

ORDINANCE NO. 20-40

AN ORDINANCE AMENDING ORDINANCE NO. 19-87
(2020 APPROPRIATION ORDINANCE) FOR A
SUPPLEMENTAL APPROPRIATION TO THE TRAILS,
OPEN SPACE AND PARKS FUND IN THE AMOUNT OF
\$6,243,900 FOR THE PHASE I ACQUISITION OF
APPROXIMATELY 284 ACRES OF PROPERTY FOR THE
PURPOSE OF PUBLIC OPEN SPACE AND TRAILS

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
COLORADO SPRINGS:

Section 1. That Ordinance No. 19-87 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$6,243,900, inclusive of the purchase prices, administrative settlement and professional services fee for acquisition of approximately 284 acres of property for the purpose of public open space and trails located at the Black Canyon Quarry and the frontage area of the Pikeview Quarry. The source of funds for the land acquisition is the TOPS fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
