

ORDINANCE NO. 19-88

AN ORDINANCE AMENDING ORDINANCE NO. 18-118 (2019 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE 2C-ROAD REPAIR, MAINTENANCE AND IMPROVEMENT FUND IN THE AMOUNT OF \$3,000,000 FOR ADDITIONAL CAPITAL EXPENDITURES IDENTIFIED FOR 2019

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 18-118 is hereby amended by increasing the 2C-Road Repair, Maintenance and Improvement Fund expenditure appropriation in the amount of \$3,000,000 in order to fund additional capital expenditures in 2019. The source of funds is the 2C Fund available fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.




