

ORDINANCE NO. 16- 101

AN ORDINANCE AMENDING ORDINANCE NO. 15-86 (2016 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE CONSERVATION TRUST FUND IN THE AMOUNT OF \$100,000 FOR THE PURPOSE OF SUPPLEMENTING THE PARKS, RECREATION AND CULTURAL SERVICES 2016 WATER BUDGET

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 15-86 is hereby amended by increasing the Conservation Trust Fund revenue and expenditure appropriations in the amount of \$100,000 for the purpose of supplementing the Parks, Recreation and Cultural Services 2016 water budget. The source of funds is actual revenue collections exceeding budget.


Section 2. The appropriation is solely for the purpose of funding water expenses. Any unspent budget remaining in the account after all 2016 bills are paid will be returned to the Conservation Trust Fund fund balance.

Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.





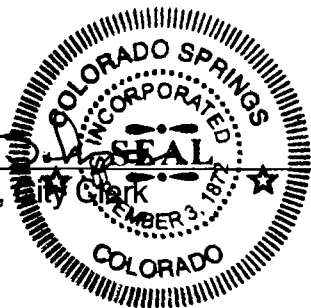
