Anne Markley, Chief Executive Officer, Trust, Education, Safety, Support, and Action (TESSA), provided an overview of their mission, who they serve, services, confidential victim advocates, impact, partnerships/affiliations, and Douglas County expansion.

President Crow-Iverson asked if TESSA serves individuals from other areas of the state. Ms. Markley stated the Colorado Springs location serves people from El Paso and Teller County.

Councilmember Leinweber requested additional information regarding housing assistance. Ms. Markley explained how they look at safe housing for individuals coming from out of state and their limited housing resources which are currently only funded through the Victims of Crime Act (VOCA). She stated they are anticipating additional funding through the United States Department of Housing and Urban Development (HUD) soon which will help individuals in the way of housing.

Councilmember Rainey asked if TESSA has a relationship with Safe Passage. Ms. Markley confirmed they did through their partnership with UCHHealth.

Councilmember Rainey asked if the representatives of pro se court cases have legal expertise. Ms. Markley stated they have a Chief Legal Officer

who is an attorney who provides all the legal counsel as well as legal advocates which provide additional support.

Councilmember Rainey asked how many pro se cases TESSA has provided legal support for. Ms. Markley stated she will provide that information.

Councilmember Gold asked what the population of El Paso and Teller County is. Ms. Markley stated with the addition of Douglas County, which is approximately 450,000, they will be serving a total population of 1.1 million people.

Allison Stocker, Senior Planner, City Planning Department, presented the Resolutions approving an amended Service Plan and authorizing issuance of debt by the Tuscan Foothills Village Metropolitan District in an amount not to exceed \$1,389,000 located northwest of the intersection of Centennial Boulevard and North 30th Street. She provided an overview of the Service Plan Amendment, bond issuance, district location, features, changes to mill levies, maximum debt, 2025 bond, and next steps.

Councilmember Donelson stated after speaking with representatives from the district and because of the support of the residents who live there, he supports these proposed Resolutions.

Councilmember Leinweber requested additional information regarding the need for the restructuring of the debt. Jak Pattamasaevi, District Manager, Tuscan Foothills Village Metropolitan District, representing the applicant, provided an overview of the Tuscan Foothills Village community, request of Council, goals, objectives, Service Plan requirements, impact on debt mill, impact on operating revenue, and increase of debt limit.

Michael Montgomery, Deputy City Council Administrator, presented the Ordinance amending the City Code pertaining to retail marijuana and expenditures of the Special Fund. He provided an overview of the history of the Ordinance, current Code/budget authority, proposed amendments, and next steps.

President Crow-Iverson stated this information is important for her colleagues with the Opioid Council and Health Foundation to make sure these dollars are matched and go further which is the best use for citizens at this time.

Councilmember Donelson asked what is included in Public Safety Programs. Ben Bolinger, Legislative Counsel, City Attorney's Office, stated those were not defined in the initiated Ordinance, but City Council has the authority to define it in City Code, appropriate a bulk of money, and this proposed Ordinance allows Council to make recommendations to the Mayor, but it would not be binding because it would ultimately be the Mayor's decision as to which of the three categories the money will be spent on.

Councilmember Donelson stated the City is short on funding for the Colorado Springs Police Department but does already spend a lot of money on mental health and Post Traumatic Stress Disorders (PTSD) programs and thinks citizens would support law enforcement funding with this money.

10. Councilmember Reports and Open Discussion

Councilmember Bailey requested an update regarding the Colorado Springs Airport Utility Infrastructure. Jamie Fabos, Chief of Staff, stated they believe they have found alternative funding for the substation to lessen

the risk to the Colorado Springs Airport which they will be firming up on June 13, 2025.

Councilmember Gold stated she and Councilmember Rainey attended the event at the Colorado Springs Airport on Saturday, June 7, 2025, for their first inaugural flight to Cancun.

Councilmember Rainey stated he has been having conversations with the Chair and Vice Chair of the Law Enforcement Transparency Advisory Commission (LETAC), the Chief of the Colorado Springs Police Department (CSPD), CSPD Lieutenants, and other staff members to see what the future holds for LETAC and CSPD.

Councilmember Leinweber stated he has attended three of Mayor Yemi's Listening Tours, participated in the Pikes Peak Outdoor Recreation Alliance (PPORA), Colorado Parks and Wildlife, and Parks, Recreation, and Cultural Service, Get Outdoors Day on Saturday, June 7, 2025, and on Thursday, June 5, 2025, he attended the El Pomar Colorado Conference on Civil Discourse. He commented that on Tuesday, June 10, 2025, from 5:30 PM-7:00 PM, at 2855 Mesa Road, Colorado Springs Utilities will be hosting a public meeting for the Norris Slope Recreation Area.
