Project History and Context

PROJECT HISTORY AND CONTEXT

- Passenger rail service has been an ongoing conversation...
 - 2010: Rocky Mountain Rail Authority High Speed Rail Feasibility Study
 - o 2011: North I-25 EIS Commuter Rail Update
 - 2014: Advanced Guideway System Feasibility Study
 - 2014: ICS (Interregional Connectivity Study)
 - 2018: Colorado Freight and Passenger Rail Plan
 - 2020: Front Range Passenger Rail (FRPR)
 Alternatives Analysis



ONGOING EFFORTS

2021-Present: Southwest Chief Thru-car Extension Analysis

- Led by CDOT and the FRPR
- Options to extend Amtrak's Southwest Chief
- La Junta to Pueblo to Colorado Springs
- Focuses on the technical feasibility, service, and infrastructure

2022-Present: FRPR Service Development Plan (SDP)

- Led by CDOT and the Passenger Rail Commission
- Currently in procurement (anticipated start summer 2022)
- Focuses on passenger service integration with the freight railroads and infrastructure needs

Future Passenger Rail Efforts and Projects

- Led by CDOT and the Passenger Rail Commission/District
- Potential future activities:
 - Identifying funding
 - Advancing service planning
 - Railroad coordination and agreements
 - Design and construction
 - Operations


PROJECT OVERVIEW

Identify a passenger rail station location...

- Position the City to respond to future passenger rail
 - Potential Southwest Chief extension
 - Potential Front Range Passenger Rail
- Consider connectivity, City/regional plans, and local stakeholders
- Provide direction to CDOT/Passenger Rail Commission
 - City's preferred site
 - Understanding the City is not the funder/implementer





 - General space for station needs (potential available land)
 - Proximity to origins and destinations
