AN ORDINANCE AMENDING ORDINANCE NO. 18-118 (2019 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE TRAILS, OPEN SPACE AND PARKS FUND IN THE AMOUNT OF \$1,284,000 FOR ACQUISITION OF APPROXIMATELY 164 ACRES OF PROPERTY FOR THE PURPOSE OF PUBLIC OPEN SPACE AND TRAILS AS AN EXTENSION OF THE CHEYENNE MOUNTAIN STATE PARK

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 18-118 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$1,284,000, inclusive of real estate transaction costs and building demolition costs and acquisition of up to 164 acres of property for the purpose of public open space and trails as an extension of Cheyenne Mountain State Park. The source of funds for the land acquisition and demolition of structures is the TOPS fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
