#### **ORDINANCE NO. 20-71**

AN ORDINANCE AMENDING MULTIPLE SECTIONS WITHIN CHAPTER 6 (NEIGHBORHOOD VITALITY/COMMUNITY HEALTH) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO ANIMAL FEES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 110 (Specific Animals Prohibited; Exception) of Article 7 (Regulation of Animals - General Provisions) of Chapter 6 (Neighborhood Vitality / Community Health) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

6.7.110: SPECIFIC ANIMALS PROHIBITED; EXCEPTION:

- D. Exception: Potbellied pigs may be owned or kept within the City under the following conditions:
  - 1. The owner or keeper of a potbellied pig must register the pig with the City's animal control services provider immediately after acquiring the animal. The fee for the required potbellied pig registration shall be twelve dollars (\$12.00) seventy five dollars (\$75.00).

Section 2. Section 112 (Exotic Animals; Application for Permit) of Article 7 (Regulation of Animals – General Provisions) of Chapter 6 (Neighborhood Vitality / Community Health) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

6.7.112: EXOTIC ANIMALS: APPLICATION FOR PERMIT:

A. All applications for a permit required by section 6.7.111 of this article shall be made on the prescribed form. A fee of twenty five dollars (\$25.00) seventy five dollars (\$75.00) shall accompany the application, five dollars (\$5.00) of which shall be considered an application fee and shall not be refunded if the permit is denied.

Section 3. Section 119 (Dangerous Animal License) of Article 7 (Regulation of Animals - General Provisions) of Chapter 6 (Neighborhood Vitality / Community Health) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

## 6.7.119: DANGEROUS ANIMAL LICENSE:

A. \* \* \*

B. All applications for a dangerous animal license shall be made to the City on the prescribed form. A fee of twenty five dollars (\$25.00) one hundred dollars (\$100.00) shall accompany the application, five dollars (\$5.00) of which shall be considered an application fee and nonrefundable.

\* \* \*

Section 4. Section 108 (Registration of Hoofed Pets) of Article 8 (Regulation of Animals - Pets Section) of Chapter 6 (Neighborhood Vitality / Community Health) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

### 6.8.108: REGISTRATION OF HOOFED PETS:

The owner or keeper of a hoofed pet must register the hoofed pet with the City's animal control services provider immediately after acquiring the animal. The fee for the required hoofed pet registration shall be twelve dollars (\$12.00) seventy five dollars (\$75.00). (Ord. 14-28)

Section 5. Section 103 (Permit) of Article 11 (Regulation of Animals – Pigeons) of Chapter 6 (Neighborhood Vitality / Community Health) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows: 6.11.103: PERMIT:

On application signed by the owner, on the form as shall be provided by the Humane Society, wherein the owner shall certify that the owner's loft(s) comply with applicable Building and Zoning Codes, and upon payment of a fee of twenty five dollars (\$25.00)seventy five dollars (\$75.00), a permit shall be issued to the owner, which shall remain in full force and effect unless suspended or revoked, or unless the use of the loft be discontinued for a period of one year.

Section 6. This ordinance shall be in full force and effect as of January 1, 2021, after its final adoption and publication as provided by Charter.

Section 7. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
