AN ORDINANCE AMENDING ORDINANCE NO. 13-77 (2014 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE LODGERS & AUTO RENTAL TAX (LART) FUND IN THE AMONT OF \$434,000 FOR THE FINAL 2014 LART PAYMENT TO THE COLORADO SPRINGS CONVENTION & VISITORS BUREAU

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 13-77 is hereby amended by increasing the expenditure appropriations of the Lodgers & Auto Rental Tax (LART) Fund in the amount of \$434,000 for final 2014 payment LART payment to the Colorado Springs Convention & Visitors Bureau (CVB). The source of funds is 2014 LART revenue collected in excess of the 2014 budget.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
