

RESOLUTION NO. 93-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLORADO
SPRINGS APPOINTING MEMBERS OF THE BOARD OF DIRECTORS
OF THE INTERQUEST SOUTH BUSINESS IMPROVEMENT DISTRICT

WHEREAS, the Interquest South Business Improvement District (the "District") was organized by the City Council of the City of Colorado Springs by Ordinance No. 04-238 on October 26, 2004 within the City of Colorado Springs; and

WHEREAS, pursuant to Ordinance No. 04-238, in accordance with Section 31-25-1209(d), C.R.S., the Board of Directors of the District have been elected by the eligible electors of the District as provided by law; and

WHEREAS, the City of Colorado Springs is considering amendment of Ordinance No. 04-238, in the form of Ordinance No. 15-71 which amendment allows City Council to fill vacancies on the District's Board of Directors by appointing members to serve until the next regular special district election; and

WHEREAS, there currently are no members currently serving on the District's Board of Directors; and

WHEREAS, City Council intends to appoint two electors of the District to serve as members of the Board Directors until the next regular election; and

WHEREAS, the names of Bethany Sather and Stacie M. Tucker have been submitted to the City by the District as the individuals recommended to fill existing vacancies on the Board of Directors; and

WHEREAS, Bethany Sather and Stacie M. Tucker are electors of the District, as that term is defined at Section 31-25-1203(4)(a), C.R.S., and are therefore qualified for membership on the Board of Directors of the District.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS, COLORADO:

1. Contingent upon passage of Ordinance No. 15-71, City Council hereby appoints Bethany Sather and Stacie M. Tucker to serve as members of the Board of Directors of the Interquest South Business Improvement District until the next regular special district election.

2. Upon their appointment, Bethany Sather and Stacie M. Tucker shall carry out the responsibilities required of the District's Board of Directors by the Business Improvement District Act and other law.


3. If and after Ordinance 15-71 becomes effective, within thirty (30) days of the effective date of this Resolution, Bethany Sather and Stacie M. Tucker shall each appear before an officer authorized to administer oaths and take an oath that she shall faithfully perform the duties of her office as required by law and will support the constitution of the United States, the constitution of the State of Colorado, and laws made pursuant thereto.

4. The City Clerk is hereby directed to cause an executed copy of this Resolution to be provided to the District.
