Now the parks department wants to extensively ramp up recreation and parking in BOS to include paragliding (!) which studies show is detrimental to wildlife. BOS is habitat for a variety of wildlife including Rocky Mountain Bighorn Sheep, a State of Colorado designated "species of greatest conservation need."

The city's parks department contracted a new master plan without asking the citizens first. Later, in their "public input process," they asked citizens to weigh in on pre-determined "options" (of which making BOS a nature preserve was not one).

Good morning Mr. Deitemeyer,

I'm an active & outdoorsy Rockrimmon resident & proud COS citizen; married w/ 2 young children; we are participants & volunteer coaches for our Parks, Recreation & Cultural Services [PR&CS] youths sport program. I joined the BOSM&MP conversation roughly May/June of 2023, and signed up to receive [but never have received] project updates from PR&CS. During the summer months I emailed & called your office [using the Gmail acct & phone number provided by Tapis Associates] to learn of planning session locations/times, but those messages were left unanswered. I was however able to attend the Oct 2023 meeting @ Flying W, afterwards I emailed the Gmail acct again & completed all post meeting surveys, but didn't receive a response. I attended Jan 2024 Neighborhood meeting @ Trace Church, then spoke during public comments @ 2/13/24 City Council meeting, attended Councilmember Dave Donaldson's 2/29 meeting @ Woodmen-Roberts Elementary, attended Parks Advisory Board master plan approval meeting on 4/11 in person & by phone. Unfortunately the only opportunity I've had to speak publicly in front of or with you [& other Parks leadership] was @ the Woodmen-Roberts and PAB 4/11 approval meeting, but the PAB meeting experienced technical difficulties and my phoned-in public comment was not heard.

These efforts to communicate with Parks leadership & Tapis Associates have remained ineffectual. Ia slo tried joining the Stakeholder group, and was assured there would be more time and opportunities to discuss the new master plan with Parks leadership. Likewise I still have remaining questions and serious concerns for BOS, and am respectfully sending this email ahead of the 6/10 City Council appeal in case I'm unable to make a formal public comment during the hearing:

- 1. Can you describe PR&CS process to a] select the stakeholder group participants and b] which local HOAs were contacted for inclusion in the BOSM&MP's Stakeholder group?
 - According to BOSM&MP Appendix A-1 [click here to view] the Stakeholder group met March & April 2023; 26 area organizations/HOAs were invited; 15 reps from 11 organizations chose to participate.
 - I currently volunteer for our 595 home HOA here in Rockrimmon; our HOA board did not receive an invitation from either COS city, COS PR&CS or Tapis Associates to join this Stakeholder group.
- 2. Can you describe PR&CS's master plan implementation process for our open spaces & parks? More than a few times COS citizens were told BOS's original master plan required redesign based off BOS's 2018 land acquisition; can you describe this requirement in detail— specifically define when a new master plan is needed, and when PR&CS will relay that information to the public for inclusion in the master plan process. For reference:
 - 64 Acres Added to Blodgett Open Space, Oct 17, 2018: The TPL, in partnership with the city of Colorado Springs, today announced the protection of 64 acres adjacent to the Blodgett Open Space. The TFPL bought the land for \$768,500 from T. Slattery LLC, 3 parcels total.
 - Each of the three parcels already has a conservation easement held by El Paso County.
- 3. Can you please make public-- the three new BOS parking lot designs, specifically the 2018 purchased parcels as those hold 3 separate conservation easements.
 - Appendix B-3 [click here to view] states "Easement documents and other agreements mentioned above can be found in Appendix D.///", however, Appendix D "Existing Legal Documents" is blank or not available for me to view online.
- 4. Please describe PR&CS current vision regarding the use of e-bikes and other motorized equipment usage w/in BOS. I understand there is currently a PR&CS action committee formed to define these rules, and that e-bikes are legally allowed on all COS urban trails.
 - Will BOS be considered an urban trail system, allow e-bike usage and/or will e-bike speeds be limited @ BOS?
- 5. What are PR&CS plans to follow Federal NEPA requirements for adjacent USFS land access? Roughly what do you expect additional taxpayer costs will be in order for us to hire

another consultant to fulfill these NEPA requirements? Does the below BOSM&MP quote indicate PR&CS does <u>not</u> have to follow the formal NEPA public input process? For reference:

- Master Plan pg 61 [click here to view], Phase 2 Implementation "The city will participate in the NEPA public process and is <u>not</u> required by this management plan to host a separate public process."
- [Click here to view] EPA's National Environmental Policy Act [NEPA] webpage.
- [Click here to view] this 2/23/24 Gazette article quotes you, Mr Deitemeyer, COS Parks & Rec Dept, "Should the plan be approved, Deitemeyer said work this year could start on a new parking lot and trailhead in an area planned for multi-use and mountain bike-only trails. He also said the city could move forward in seeking a consultant to satisfy the U.S. Forest Service's requirement under the National Environmental Policy Act [NEPA] seen as the first step toward land managers partnering on a formal trail to Blodgett Peak's summit
- NEPA requirements would require the inclusion of [at minimum] an Environmental Impact Statement (EIS) and/or an Environmental Assessment (EA). As I understand this, the before-mentioned assessments are not [currently] required for our city's projects.
- 6. Cultural Resource Protection. I was elated to read we have archaeological sites w/in BOS. Please clarify where these sites were found, the sites' relation to mtnb and/or hiking trails, and what methods of preservation are being used for this area. For reference:
 - Master Plan pg 53 [click here to view] Blodgett Open Space contains historical and archaeological resources related to the prehistoric period and historical agriculture and development activities.
 - All known significant archaeological sites have already been impacted by modern recreation in the area. Therefore, the best management practice is to preserve sites that are threatened and avoid significant sites during any future ground-disturbing construction activities.
 - W/o following NEPA standards/assessment guidelines, how do we know for sure we are not ruining known & unknown archeological sites?
 - It should be noted that without a state or federal nexus [e.g., funding or permitting], future projects will not legally require compliance with the Colorado State Register Act or Section 106 of the National Historic Preservation Act [as amended 1966, NHPA].
 - Until the involvement of a state or federal nexus, all cultural resource management is considered due diligence and best practices, and the City is not obligated to complete cultural resource investigations or consultation on project effects with the Colorado State Historic Preservation Officer.
- 7. Conservation Easement, Easements and Right of Way Information. I'd appreciate help in clarifying what portion of the 2.3 million [I estimated these costs] of the Quarry Trailhead Improvements & Amenities work is being used to repair 2 drainage ponds located on the Quarry's property? Could the southern pond, Quarry Pond 517, be considered a 'dam'? For reference:
 - Appendix B-3 [click here to view] The City supports reclamation of the Pikeview Quarry. City property includes previous disturbance from required stormwater management facilities from the Pikeview Quarry operations included within the DRMS permit area. Portions of the property are subject to approved, agreed-upon and permitted reclamation requirements by Riverbend Industries. This impact is immediately adjacent to the quarry site and accounts for approximately 31-acres of the open space.
 - Appendix F-4 [click here to view] Drainage Observations: "Initial Recommendations for the southern pond, Quarry Pond 517, include the following if it is to remain in service:
 - "Repair or modify any deficiencies found in the inspections and analysis.
 - Investigate the configuration of the spillway armoring.
 - Collaborate with the State Dam Safety office to determine if the pond needs to meet the rules for jurisdictional dams.
 - Consider reconfiguring the pond to meet the criteria for non-jurisdictional dam status "
 - From what I can see this drainage work could cost COS taxpayers upwards 2.3 million [estimated], is this correct or please help me breakdown the costs more accurately. For reference:
 - Master Plan pg 84 [click here to view], Quarry Trailhead Improvements & Amenities Estimated Quantities & Implementation Costs = 300k; plus Quarry Meadow Drainage Improvements 25 acres [dam inspection, regrading and revegetation] = 2 million.

This also increases the project's overall Design Costs = 782k [assume 15% of the project implementation total of \$ 5,214,100].

- Also see Master Plan pg 61 [click here to view], Phase 3 Implementation "If the city accepts the Pikeview Quarry, a separate planning process will be undertaken. At that time, the southern area of Blodgett Open Space may be reconsidered as part of that planning process."
 - Does this mean Parks Leadership is able to re-design Blodgett's southern portion [perhaps 25-30 acres] w/o a formal public engagement process? If yes, I have serious concerns about not being included in that process as well.

I appreciate your time and consideration. Like you, I also care deeply about our public wildlands and parks. Thank you.

I have emailed you all several times since late Aug/Sep 2023, after I first learned about the

Blodgett Master Plan.

I took great pains and time in my first several emails, Aug 2023-Dec 2023, to address the two main perspectives from which I was viewing that plan: as an adjacent resident and home owner who experiences all that would/(will) be so greatly negatively affected as a result of this plan, and as a general hiker and dog walker who enjoys meeting different people on the trails (hikers, runners, dog walkers, and bikers) as well as the raw nature, peace, serenity, and physical and mental health benefits that the trails through the open space provide. This pristine land and area cannot be treated like a "city park" or outdoor amusement park.

As I proceeded to do what little bit I could to get the word out to some of my neighbors, and share with others I met along the way on walks, etc., I was met with responses like "Don't waste your time... the city will do whatever it wants and won't pay any attention to us." I remained hopeful, and actually trusted in our CS Parks Dept, Parks Advisory Board, TOPS Committee, and City Council. I couldn't believe that we wouldn't be heard... so I pressed on.

It grew clearer to me that the Parks Department was not paying attention to those who live amongst the wildlife (deer, etc) that live in our neighborhoods on both sides of the Centennial Blvd and Woodmen Road corridor, and cross back and forth daily and nightly. Nor was the Parks Dept recognizing the physical danger in which they are putting all those who use the trail system on foot (non-bikers).

I grew weary and I grew very stressed, all which began affecting not only my physical health but my emotional health. I later found that those same experiences were happening to other residents and home owners who live adjacent up and down the Blodgett Open Space and Quarry corridor.

By the end of Jan 2024, after the "final plan" was released and another "community presentation" was held, I was at a loss. I realized the reality of the adjacent residents and non-biking open space trail users, as well as all the wildlife (deer, etc) that live along and cross back and forth of the Centennial Blvd and Woodmen Road corridor, had not been taken into consideration... it was all for show.

So, my emotions got the best of me... took over, actually... and I sent a very emotional, condemning, and rude email. And then after the TOPS Committee and Parks Advisory Board each voted in favor of implementing the new Blodgett Master Plan I sent another email in which I attempted to contain my emotions better, though it was still emotional,

condemning, and rude.

I have been wondering why I have been so depressed, and had acted out this way in my emails to you, and to others. Today I was convicted (by the Holy Spirit) about who I have become throughout these past eight to nine months. That is not who I am.

I am ashamed of my actions and words, and I am sorry. It was wrong to lash out to you in that way. I knew better, but I didn't do better. I hope you will forgive me. Even if you don't, I am still sorry.

I appreciate your time, and I pray for the safety, security, and peace to all in this great city. Thank you.

I hope this Monday morning e-mail finds you well. First, I want to again express my appreciation for your engagement with your constituents, including me, regarding the Blodgett Open Space Master & Management Plan. Your responses to my e-mails, and your outreach to me by phone, demonstrate that individual citizens like me matter and are important to you.

You may recall that my initial contact with you last Fall was to express the concern of my family and my neighbors with the proposed Orchard Valley Trailhead, which is directly above and to the north of our home and our cul-de-sac in Oak Valley Ranch. The draft plan presented at the October 2023 community workshop included a relocated and expanded Orchard Valley Trailhead parking area with 60 slots, a new access road on the Oak Valley Ranch skyline above our home, and addition of amenities such as signage and a toilet on our neighborhood skyline. Needless to say, my family, my neighbors, and our HOA were all mortified by this prospect, and we began contacting you and the Parks staff about it. Not only were you responsive to our concerns, so was the Parks staff.

The updated plan has been dramatically revised to mitigate the concerns of citizens like us. The planned Orchard Valley Trailhead parking lot has been scaled back to resemble its current footprint, with the access road remaining where it currently is and the amenities located at the interior of the trailhead away from the Oak Valley Ranch skyline. Additionally, the removal of the eyesore barn and shed near the intersection is a top priority in the new plan, and that will be a much welcome aesthetic improvement to the local landscape.

Throughout this process, I've received multiple courteous and cordial e-mail replies from Ms. Haley and Mr. Deitemeyer in Parks & Rec. In addition to the October meeting at Flying W Ranch, I attended the community meeting at Trace Church and your town hall meeting at Woodmen-Roberts Elementary. I've also been present or called in for the Parks Advisory Board and TOPS Working Committee meetings where Blodgett Open Space was discussed. The opportunities for citizen input into the planning process from October 2023 onward have been plentiful as far as I'm concerned.

While I've been primarily focused on the Orchard Valley Tailhead since its southern boundary is 40 yards above our backyard, I'm also very much interested in the planning for the larger expanse of the entire Blodgett Open Space. Our son and his family live a half mile west of us directly in front of the Pikeview Quarry, so they have the new southern addition of the open space directly behind their home as well. We think there's much goodness in the plan as it now exists after citizen input and revisions.

The new Quarry Trailhead will be a fantastic access point for the open space. The trails will be fun and exciting to hike, and there's no doubt in my mind that people who would otherwise park at the North Trailhead will instead gravitate to the Quarry Trailhead. In particular, the mountain bikers will head there because it gives them better access to the new bike trails and it's at the bottom of the open space elevationwise. This means less encounters between mountain bikers and hikers in the north and middle sections of the open space.

I sincerely believe that the wildlife will fare much better under the structure of the new plan than it currently does now without that structure. The consideration of wildlife corridors in the new plan, along with the overall reduction in trail mileage due to the closure of unsanctioned trails, will provide better opportunities for the wildlife to avoid human interaction. Also, the adaptive management approach incorporated into the plan will provide for the ability to modulate activity in targeted portions of the open space should CPW biologists determine the presence of an adverse impact to the wildlife.

Speaking of wildlife, in the 25 years we've lived here we've never seen a single bighorn sheep in the area that comprises the Blodgett Open Space. And I get up before dawn to hike for miles in the open space on a weekly basis. I see bighorn sheep often in Garden of the Gods, in Mountain Shadows residential areas, and there was even a herd of rams at the Flying W Ranch parking lot when we exited the October community meeting. They never seem disturbed by human activity in vehicles or on foot. The notion that the Blodgett Open Space Master & Management Plan puts the local bighorn sheep herd in imminent peril is unscientific at best--CPW has provided no such warning. More likely, predictions of the impending destruction of the bighorn sheep herd are exaggerations designed to inflame public passions.

There's been an intense campaign on social media spearheaded by vocal opponents of the plan that has proliferated "Save The Bighorns" and "Save Blodgett" catchphrases. No doubt those people have been communicating with you and your colleagues on Council. The bighorns don't need saving from the plan, and neither does Blodgett. Rather, the plan needs saving from the apocalyptic vision propagated by its opponents. Their change.org petition to turn Blodgett Open Space into a nature preserve has garnered a lot of signatures based upon emotional and hyperbolic language in the Nextdoor.com and Facebook posts being used to disseminate it.

From what I can tell, the most strident opposition of the plan largely stems from a few Westsiders, some of whom reside near the open space like my family and my son's family. However, I don't believe they have the best interests of the larger Colorado Springs community and surrounding areas at heart. I know them not only from their social media posts, but also from meeting them in person. Some of them are, in my opinion, ardent but misguided animal welfare activists. One of them told me face-to-face last October that there's not a single thing in the plan that she supports--She said she's against it in its entirety.

Some opponents of the plan have suggested that the increased availability of parking at the North and Quarry Trailheads will result in a tremendous influx of people using

the open space, complicating evacuation efforts in the case of a wildfire. I personally don't think that will be the case, and more parking spots doesn't necessarily correlate to a greater possibility of evacuation traffic jams (especially since many of the parking spots will remain empty). I think the carefully considered parking lots proposed in the revised plan, along with the security recommendations being evaluated, will improve public safety along Woodmen Road and in the parking lots themselves. Just as CPW didn't identify impending danger to the bighorn sheep herd, CSFD hasn't noted increased hazard from the possibility of wildfires. I listened to Fire Chief Royal at your town hall gathering, and as someone who was caught up in the Waldo Canyon Fire evacuation, I came away with the impression that our processes for fighting wildfires and conducting evacuations are vastly improved since 2012.

I believe the citizens of Colorado Springs will be best served if our elected leaders rely upon the expertise of the professionals instead of the entreaties of the emotionals. To that end, I wholeheartedly recommend that Council approve the Blodgett Open Space Master & Management Plan when making a decision on the appeal of the unanimous Tops Working Committee approval and the 7-1 Parks Advisory Board approval.

Given the locations of our homes right next to the open space, I don't know of any families who are more impacted by the plan than my family and our son's family. We aren't mountain bikers or paragliding enthusiasts--Just adjacent neighbors of the open space who enjoy hiking in it and observing its wildlife. Unlike some Westsiders, we don't consider the open space to be our own personal playground and nature preserve. And we believe the approved Blodgett Open Space Master & Management Plan provides the best opportunity for all of Colorado Springs' citizens to also enjoy this wonderful property.

5 years from now, the nearby bighorn sheep and other wildlife will be thriving as it is today in our busy Garden of the Gods park, and all of our great city's citizens will be benefiting from a very much improved Blodgett Open Space. Your approval of this plan will help make it one of our city's crown jewels.

Our son and his family live a half mile west of us directly in front of the Pikeview Quarry, so they have the new southern addition of the open space directly behind their home as well. We think there's much goodness in the plan as it now exists after citizen input and revisions. The new Quarry Trailhead will be a fantastic access point for the open space. The trails will be fun and exciting to hike, and there's no doubt in my mind that people who would otherwise park at the North Trailhead will instead gravitate to the Quarry Trailhead. In particular, the mountain bikers will head there because it gives them better access to the new bike trails and it's at the bottom of the open space elevation-wise. This means less encounters between mountain bikers and hikers in the north and middle sections of the open space.

I sincerely believe that the wildlife will fare much better under the structure of the new plan than it currently does now without that structure. The consideration of wildlife corridors in the new plan, along with the overall reduction in trail mileage due to the closure of unsanctioned trails, will provide better opportunities for the wildlife to avoid human interaction. Also, the adaptive management approach incorporated into the plan will provide for the ability to modulate activity in targeted portions of the open space should CPW biologists determine the presence of an adverse impact to the wildlife.

Speaking of wildlife, in the 25 years we've lived here we've never seen a single bighorn sheep in the area that comprises the Blodgett Open Space. And I get up before dawn to hike for miles in the open space on a weekly basis. I see bighorn sheep often in Garden of the Gods, in Mountain Shadows residential areas, and there was even a herd of rams at the Flying W Ranch parking lot when we exited the October community

meeting. They never seem disturbed by human activity in vehicles or on foot. The notion that the Blodgett Open Space Master & Management Plan puts the local bighorn sheep herd in imminent peril is unscientific at best--CPW has provided no such warning. More likely, predictions of the impending destruction of the bighorn sheep herd are exaggerations designed to inflame public passions.

There's been an intense campaign on social media spearheaded by vocal opponents of the plan that has proliferated "Save The Bighorns" and "Save Blodgett" catchphrases. No doubt those people have been communicating with you and your colleagues on Council. The bighorns don't need saving from the plan, and neither does Blodgett. Rather, the plan needs saving from the apocalyptic vision propagated by its opponents. Their change.org petition to turn Blodgett Open Space into a nature preserve has garnered a lot of signatures based upon emotional and hyperbolic language in the Nextdoor.com and Facebook posts being used to disseminate it.

From what I can tell, the most strident opposition of the plan largely stems from a few Westsiders, some of whom reside near the open space like my family and my son's family. However, I don't believe they have the best interests of the larger Colorado Springs community and surrounding areas at heart. I know them not only from their social media posts, but also from meeting them in person. Some of them are, in my opinion, ardent but misguided animal welfare activists. One of them told me face-to-face last October that there's not a single thing in the plan that she supports--She said she's against it in its entirety.

Some opponents of the plan have suggested that the increased availability of parking at the North and Quarry Trailheads will result in a tremendous influx of people using the open space, complicating evacuation efforts in the case of a wildfire. I personally don't think that will be the case, and more parking spots doesn't necessarily correlate to a greater possibility of evacuation traffic jams (especially since many of the parking spots will remain empty). I think the carefully considered parking lots proposed in the revised plan, along with the security recommendations being evaluated, will improve public safety along Woodmen Road and in the parking lots themselves. Just as CPW didn't identify impending danger to the bighorn sheep herd, CSFD hasn't noted increased hazard from the possibility of wildfires. I listened to Fire Chief Royal at your town hall gathering, and as someone who was caught up in the Waldo Canyon Fire evacuation, I came away with the impression that our processes for fighting wildfires and conducting evacuations are vastly improved since 2012.

I believe the citizens of Colorado Springs will be best served if our elected leaders rely upon the expertise of the professionals instead of the entreaties of the emotionals. To that end, I wholeheartedly recommend that Council approve the Blodgett Open Space Master & Management Plan when making a decision on the appeal of the unanimous Tops Working Committee approval and the 7-1 Parks Advisory Board approval. Given the locations of our homes right next to the open space, I don't

know of any families who are more impacted by the plan than my family and our son's family. We aren't mountain bikers or paragliding enthusiasts--Just adjacent neighbors of the open space who enjoy hiking in it and observing its wildlife. Unlike some Westsiders, we don't consider the open space to be our own personal playground and nature preserve. And we believe the approved Blodgett Open Space Master & Management Plan provides the best opportunity for all of Colorado Springs' citizens to also enjoy this wonderful property.

5 years from now, the nearby bighorn sheep and other wildlife will be thriving as it is today in our busy Garden of the Gods park, and all of our great city's citizens will be benefiting from a very much improved Blodgett Open Space. Your approval of this plan will help make it one of our city's crown jewels.
