Councilmember Geislinger asked if the topic of the Closed Executive Session could be disclosed to the public. Consensus of Council agreed to the disclosure. Councilmember Geislinger stated the annexation matter to be discussed is regarding Banning Lewis Ranch.

Eileen Krauth, City Council Administrator, stated that The Farm development items scheduled for the March 27, 2018 City Council meeting are appeals. Councilmember Knight asked who filed the appeal. Peter Wysocki, Planning and Community Development Director, said the United States Air Force Academy. Jeff Greene, Chief of Staff, said the parties are currently in negotiations and the appeal may be withdrawn.

Charae McDaniel, Chief Financial Officer, presented the March 2018 financial update which represented activity through December 2017. She stated the general fund revenue variance was between .3% - .4% above projected budget and general fund expenditures are approximately \$3.6M below projected budget for the year. She explained the sales tax collections and gave an update of the 2017 grant funds, the Memorial Health System, and the economic indicators. Ms. McDaniel clarified the residential building permits being purchased for single-family and multi-family dwellings are for the number of units being built and provided the average sale price of homes for 2017 and 2018.

Councilmember Strand asked when the final audit for 2017 will be completed. Ms. McDaniel said it will be finalized in May 2018.

Councilmember Strand asked why fines revenue is continuing to decrease. Jeff Greene, Chief of Staff, stated that he will request that Colorado Springs Police Chief, Peter Carey, and Judge Hayden Kane provide a presentation regarding fines.

Councilmember Murray asked if the Gallagher amendment ratio and property taxes going down were a result of a decrease in new businesses and requested a graph depicting business licensing. Ms. McDaniel stated that business licensing does not equate into the Gallagher assessment ratio and that she will resend the presentation that was presented approximately a year ago to City Council.

Carl Schueler, Comprehensive Planning Manager, Planning and Community Development, gave a brief summary of the second amended and restated service plan for the Banning Lewis Ranch (BLR) Regional Metropolitan District. He presented the district location map and a map of the development and zoning. Mr. Schueler provided a limited history of the district, a list of eligible future regional improvement costs and identified the use of previous revenue collected of \$1M for regional wastewater improvements.

Councilmember Knight stated the district boundaries map shows that the district is expanding not shrinking. Mr. Schueler stated that is due to when it was originally created. Councilmember Knight stated the exhibit pages were blank and that street improvements indicated that there will be allowable use for improvements to local streets. Mr. Schueler agreed to provide that information. Councilmember Knight asked why a district would be acquiring water rights and asked about the equitable debt ceiling. Mr. Schueler said the petitioner is looking at inflation factors and flexibility and that the district will provide additional information.

Councilmember Murray stated that he is concerned with the repurposing of district money that was collected for wastewater and that the \$1M should be given back to the taxpayers. Mr. Schueler stated that it will be used for the regional wastewater system. Councilmember Pico said that the purpose for the money is for the same use as it was collected.

Carl Schueler, Comprehensive Planning Manager, Planning and Community Development, gave a brief summary of the proposed voluntary inclusion of a single property into the First and Main Business Improvement District (BID) No. 2. He provided a history of the district and presented a map of the area and district.

President Pro Tem Gaebler asked why this parcel was not included in district no. 1 from the initial development of the district. Russ Dykstra from Spencer Fane, LLP, representing the district, stated that the Whole Foods Market which is located on the property originally negotiated in their lease that they not be included in the BID district no. 1. President Pro Tem Gaebler asked if the Public Improvement Fee (PIF) can be charged on food items. Mr. Dykstra said that it mirrors sales tax and is not applied to food items. He said that that district no. 2 would benefit from the additional revenue from this parcel which is why it is being included in district no. 2 instead of no. 1.

Carl Schueler, Comprehensive Planning Manager, Planning and Community Development, gave a brief summary of the proposed service plan allowing for the creation of the Patriot Park Nos.1 and 2 Metropolitan Districts. He said district no. 1 would be commercial and district no. 2

would be residential. Mr. Schueler presented a map of the area and district and a map of facilities and improvements. He listed the estimated costs and financial projections.

Councilmember Pico asked about the inclusion area of already developed commercial property. Mr. Schueler said the inclusion area would be a future inclusion that would be addressed at a later time in the service plan.

Councilmember Strand asked why the City does not want the responsibility to pay and maintain the park and why the petitioner is asking for 15 mills to include it. Britt Haley, Parks Development Manager, Parks, Recreation and Cultural Services, said after extensive discussion and an environmental review it was determined that the Parks, Recreation and Cultural Services Department did not want to take on the responsibility of the park, but that the trail would still be maintained by the City.

Councilmember Knight asked what the acreage of the park was and the cost for the irrigation of it. Mr. Schueler said it is approximately nineteen acres and will provide information regarding the cost of the maintenance.

Councilmember Knight said that he is not supportive of consolidating districts under a single service plan and a single debt or the concept of residential metropolitan districts inside the City because of the new tax laws and the possibility of homeowners not being able to itemize the deduction on their taxes for the mill levy. Mr. Schueler said that the model service plan could be addressed with the petitioner at the time of presentation.

Councilmember Knight said he would like to see a letter of consent from the property owner regarding the inclusion of property. Mr. Schueler said that it would be a voluntary inclusion.

He presented a map of the Wolf Ranch master plan and the history and evolution of the district. Mr. Schueler identified the existing district geography, the district location map and listed the proposed revenue allocation.

Steve Posey, HUD Program Administrator, Community Development Division, presented the request for the transfer of City-owned property for a public purpose to Greccio Housing Unlimited, Inc. He stated the parcel is located at 4921 Templeton Gap Road and that both the City Attorney's Office and Real Estate Services Department did not find any restrictions on the property. He stated that Greccio Housing Unlimited, Inc. will be building approximately fifty units of affordable housing on this property. Mr. Posey explained the site control and the conditions that need to be met before and after the deed conveyance which will be no cost to the City.

Councilmember Strand asked if the assignability of the real estate purchase agreement was strictly to Greccio Housing Unlimited, Inc. Mr. Posey confirmed. Councilmember Strand asked what the value of the property was. Mr. Posey stated the estimated value of the property is \$570K which was donated to the City for a public purpose.

President Pro Tem Gaebler commented that this proposal not only aligns with the Innovations in Aging Group's Strategic Plan, but also the City's and City Council's Strategic Plan.

Councilmember Knight asked if this plan met the Real Estate Services (RES) plan logical purchaser test. Darlene Kennedy, Real Estate Services Manager, read 5.4 of the Real Estate Manual regarding one logical potential purchaser. Mr. Posey stated that Greccio Housing, Inc. has positioned themselves as a primary development sponsor to take on affordable housing for the community. Councilmember Knight stated that there may be additional purchasers for this property. Ms. Kennedy said through the buck slip process, it was passed internally to Mr. Posey for use prior to opening it to outside developers. Mr. Posey stated that Greccio Housing, Inc. did solicit a partnership with multiple developers for this property. He identified that there is a deadline for the Colorado Housing Finance Authority (CHFA) in order for Greccio Housing, Inc. to receive the low-income housing tax credit for the year.

Councilmember Geislinger asked if there are other developers in the community wanting to develop parcels like this. Mr. Posey said that there are and that City Council has the authority to decide if the best purpose of the property is to sell it or donate it to be developed as affordable housing.

Councilmember Geislinger asked what the average median income rent would be. Mr. Posey predicted it will be within the \$650-\$800 per month range.

Jeff Greene, Chief of Staff, commented that the collaboration with Greccio Housing, Inc. for affordable senior housing is a very specific use for this property which came from a very specific public need in the community.

Councilmember Geislinger asked if Greccio Housing, Inc. would be willing to work with other developers regarding affordable housing. Lee Patke, Executive Director of Greccio Housing, Inc., explained that being awarded

CHFA tax credit allocations for development is very difficult and that they do collaborate with groups like the Medici Group to bring these types of projects to completion.

Karen Cullen, Executive Director, Old Colorado City Associates, presented the proposal for a “creative corridor” concept connecting downtown Colorado Springs, Manitou Springs and Old Colorado City through art and culture. She stated that the 1st Friday Art Walk will begin April 6, 2018. Andy Vick, Cultural Office of the Pikes Peak Region (COPPeR) explained what is included in the Art Walks activities and the expansion of the shuttle bus to include Manitou Springs. He said there may be the prospect of a grant award from the Colorado Tourism Office due to the creative corridor.

Laurel Prud’homme, Downtown Partnership, expressed the support of the Downtown Partnership for the project.

Councilmember Knight asked if there would be any financial impact to the City. Ms. Cullen stated that there was no cost to the City.

Councilmember Knight asked if there would be implications from the language regarding adding a domestic animal to the “threaten to attack” definition. Ms. Palus stated those situations would fall under animal control rules and penalties.

Councilmember Knight commented that Chapter 6 states the owner has the duty to restrain their animal and if they do not, the animal may be declared a nuisance, but does not define what makes the animal a nuisance, off-leash, trespassing, etc. Ms. Palus stated she will review that language for clarification.

Councilmember Knight asked if the section regarding throwing or propelling an object would be eliminating Frisbee or baseball and said that the language should clarify those activities. Ms. Palus stated that she will make sure that those activities are properly addressed.

Mitchel Hammes, Neighborhood Services Manager, presented the proposed City Code revisions for Chapters 6 as it relates to the definition of the Code Enforcement Administrator.

Councilmember Geislinger stated that this Ordinance originated from a small number of landlords who are responsible for unsafe and dangerous environments for their tenants.

Mitchel Hammes, Neighborhood Services Manager, stated they have received notice of concerns regarding the conditions of several multi-family residential rental properties. He presented a graph indicating the analysis of Code Enforcement housing complaints from June - October 2017. Mr. Hammes stated eight property owners account for forty-eight percent of the cases opened. He stated the proposed Ordinance would change the language pertaining to the designation for repeat offender and chronic repeat offender and track violations by property owner rather than by unit.

Councilmember Geislinger asked if the proposed change would charge a

repeat offender violation if a person were in violation for multiple units or properties that they owned. Mr. Hammes confirmed it would.

Councilmember Pico commented that there should also be a rule against tenants damaging rental property.

Mitchel Hammes, Neighborhood Services Manager, presented the Ordinance amending the City Code to change the appeal process when there is an aggrieved property owner or tenant displeased with the notice issued by the Code Enforcement Department where it will now be heard through a municipal court appeal hearing.

Councilmember Knight asked for clarification on the proposed appeal process. Michael Curran, Division Chief, Prosecution, stated that as it currently stands the notice and order of appeals would originally go to the Planning Commission, then City Council, then district court and with this proposed change, it would be heard by the municipal court and then district court.

Councilmember Strand commented that it would go before the municipal court referee, not the municipal judge.

10. Councilmember Reports and Open Discussion

Councilmember Knight asked if the Colorado Springs Police Department could provide the number of arrests made in regards to the homeless camps and open fires. Bret Waters, Deputy Chief of Staff, agreed to provide that information.

Councilmember Strand stated that he attended the retirement ceremony of Officer Rick Hunt who retired after thirty-one years of service with the Colorado Springs Police Department. He also attended the Manitou Springs Expo. He said that he and Councilmember Pico attended a tour of the McCullough Water Treatment Plant at the United States Air Force Academy.

Councilmember Avila said that she attended three different events regarding International Women's Day.

Councilmember Strand also stated that he, President Skorman, and Councilmember Geislinger attended a meeting regarding the move of the Hitch Rack Ranch quarry and requested that even though it is an El Paso County issue that it be presented to City Council at a Work Session meeting.

Councilmember Knight commented about the existing quarry being in District 1 for over a hundred years and that this move would expedite its closing by five years.

President Skorman said that if Councilmembers are going to support this issue, they should hear both sides.

Councilmember Pico stated he has no objection to hearing both sides, but does not feel that City Council should take a specific side or schedule the topic for a Work Session meeting.

Councilmember Bennett said there is no perfect place for a quarry, but the City needs the aggregate.

Consensus of Council was to not schedule a presentation at this time.
