

ORDINANCE NO. 22 – 93

AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF COLORADO SPRINGS PERTAINING TO 0.165 ACRES LOCATED 1122 ORCHID STREET ESTABLISHING THE R-5 (MULTI-FAMILY RESIDENTIAL) ZONE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The zoning map of the City of Colorado Springs is hereby amended by the establishment of the R-5 (Multi-family Residential) zone district consisting of 0.165 acres located 1122 Orchid Street, as described in Exhibit A and depicted in Exhibit B, both of which are attached hereto and made a part hereof, pursuant to the Zoning Ordinance of the City of Colorado Springs.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.



Containing 0.165 acres (7,200 square feet), more or less.

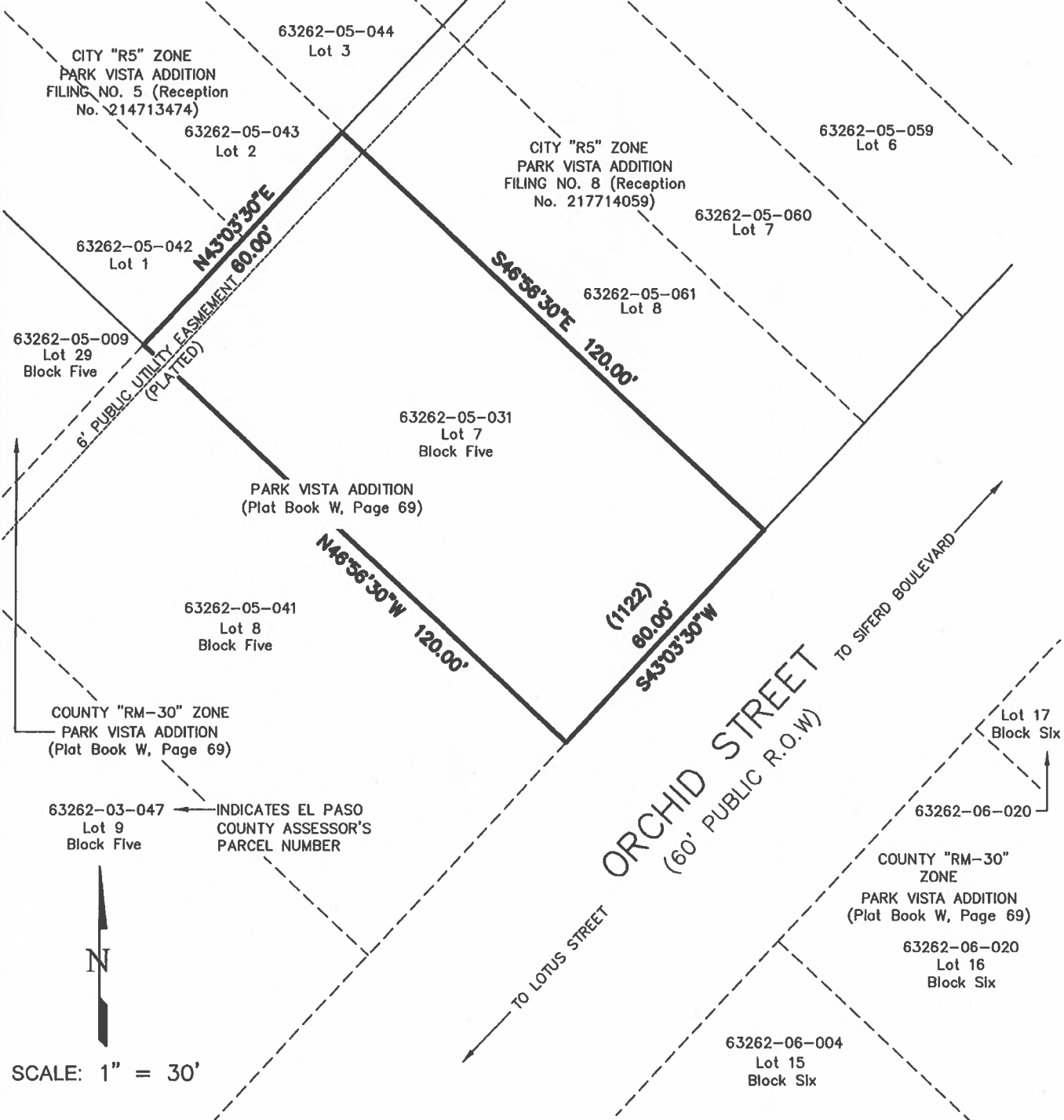
