follows:

1.2.409: APPOINT HEARING OFFICERS:

The City Attorney shall appoint Hearing Officers to resolve disputes as otherwise authorized in this Code or in the tariffs of the Utilities., and for any other reason required or permitted by

law.

This ordinance shall be in full force and effect from and after its final Section 2.
