

ORDINANCE NO. 21-52

AN ORDINANCE REPEALING ORDINANCE NO. 21-07,
AND AMENDING ORDINANCE NO. 18-120, SECTION 3
PRESCRIBING THE SALARY OF THE CITY COUNCIL
ADMINISTRATOR

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
COLORADO SPRINGS:

Section 1. The annual salary of the City Administrator shall be prescribed by ordinance in accordance with City Charter § 3-10(e).

Section 2. Ordinance No. 21-07 (An Ordinance Repealing Ordinance No. 21-07 and Prescribing The Salary of the City Council Administrator) is repealed.

Section 3. Ordinance No. 18-120 (An Ordinance Appointing the City Council Administrator and Setting the Salary of the City Council Administrator) is amended to reflect that, effective June 27, 2021, the annual salary of the City Council Administrator shall be prescribed at \$122,054, together with applicable benefits.

Section 4. This ordinance supersedes all prior ordinances to the extent such are inconsistent herewith.

Section 5. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 6. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.


