### ORDINANCE NO. 20-19

AN ORDINANCE AMENDING ORDINANCE NO. 02-24 (ORDINANCE ORGANIZING THE BRIARGATE CENTER BUSINESS IMPROVEMENT DISTRICT) TO ALLOW CITY COUNCIL TO FILL VACANCIES ON THE BOARD OF DIRECTORS OF THE BRIARGATE BUSINESS IMPROVEMENT DISTRICT BY APPOINTMENT

WHEREAS, on or about February 12, 2002, the City Council of the City of Colorado Springs organized the Briargate Center Business Improvement District (the "District") by the adoption of Ordinance No. 02-24; and

WHEREAS, Ordinance No. 02-24 provides that pursuant to Section 31-25-1209(d)(1), C.R.S., the members of the Board of Directors of the District are to be elected by the eligible electors of the District; and

WHEREAS, neither Section 31-25-1209(d)(1), C.R.S., nor Ordinance No. 02-24 provides a mechanism to fill vacancies on the Board of Directors outside of an election; and

WHEREAS, on December 5, 2019 City Council adopted Resolution No. 139-19 in order to temporarily appoint Directors to the then vacant Board of the District; and

WHEREAS, By amending Ordinance No. 02-24, the process by which vacancies on the Board of Directors may be filled will be amended to ratify the City Council's prior action in adopting Resolution No. 139-19 and to provide clear authority for future temporary board appointments as may be needed; and

WHEREAS, City Council desires to amend Ordinance No. 02-24 to provide a process whereby City Council may when necessary fill vacancies on the District's Board of Directors to serve until the next regular special district election.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 02-24 is hereby amended to add the following to the end of Section 4 of Ordinance No. 02-24:

In the event of a vacancy on the District's Board of Directors, City Council may fill such vacancy by appointing an elector of the District, by resolution, to serve as a member of the Board of Directors until the next regular special district election. Any such appointee is subject to the requirements of the Business Improvement District Act and must carry out the responsibilities required of the District's Board of Directors by the Business Improvement District Act and other applicable law. All prior acts of City Council to fill vacancies on the Board are hereby ratified.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.

### AN ORDINANCE CREATING AND ESTABLISHING THE BRIARGATE CENTER BUSINESS IMPROVEMENT DISTRICT AND APPROVING AN OPERATING PLAN AND A BUDGET FOR 2002.

WHEREAS, a petition has been filed with the City Council of the City of Colorado Springs requesting formation of a Business Improvement District in a certain area of Colorado Springs; and

WHEREAS, upon review of the petition and signatures on the petition, it appears that the petition meets the requirements of the Business Improvement District Act, Part 12 of Article 25, Title 31, Colorado Revised Statutes (C.R.S.) and the Business Improvement District policy set forth in Res. 122-00;

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Upon consideration of the petition that the Briargate Center Business Improvement District be established, the Council finds:

- (a) That the service area described in the attached Exhibit A is hereby designated as an appropriate location for new business or commercial development, in accordance with C.R.S.§ 31-25-1203(10);
- (b) That the proposed district was initiated by petition filed with the Clerk of the City Council, that the petition was duly signed and presented in of this document when received conformity with the Business Improvement District Act, Part 12 of Article 25, Title 31, C.R.S., and that the allegations of the petition are true;
  - That the services to be provided by the proposed district, as defined in the Service Plan, satisfy the purposes of the Business Improvement District Act:
  - That the City Council has fixed a place and time for a hearing on the petition;
    - That notice of such hearing has been duly published and mailed in accordance with the Business Improvement District Act;
  - That an Operating Plan and Budget for 2002 has been filed with the Clerk (f) of the City Council;

- (g) That the Briargate Center Business Improvement District is lawful and necessary, should be and is hereby created and established, and should include and does include the area set forth in Exhibit A.
- Section 2. The Briargate Center Business Improvement District is hereby organized and established for the purposes and with the powers set forth in the Briargate Center Business Improvement District Service Plan.

Section 3. The District is located within the boundaries of the City of Colorado Springs, County of El Paso Colorado, as described in Exhibit A. The Briargate Center Business Improvement District shall consist of taxable real property located within the service area that is not classified for property tax purposes as either residential or agricultural together with any taxable personal property located on the taxable real property. Residential or agricultural property located within the boundaries of the service area shall not be subject to the District's revenue-raising powers until the time as the property changes classification for property tax purposes.

Section 4. The Briargate Center Business Improvement District shall be governed by an elected board of directors as delineated in the Briargate Center Business Improvement District Service Plan. The initial board of directors election shall be held on May 7, 2002 in accordance with the provisions of Part 8 of Article 1 of Title 32 C.R.S. Micki Wadhams whose address is Collins Cockrel & Cole, PC, 390 Union Blvd., Suite 400, Denver, Colorado 80228 is hereby designated as the Designated Election Official for the District and she is hereby authorized and directed to proceed, subject to the supervision of the City Clerk, with any action necessary or appropriate to effectuate the provisions of this Ordinance, the Business Improvement District Act, and the Uniform Election Code of 1992 pursuant to which the election shall be conducted, and all other applicable laws. Among other matters, the Designated Election Official shall publish the call for nominations, appoint election judges as necessary, appoint the canvass board, arrange for the required notices of election (either by mail or publication), the printing of ballots, and direct that all other appropriate actions be accomplished.

Section 5. The 2002 Operating Plan and Budget is hereby approved.

Section 6. Any amendments to the Operating Plan and Budget of the Briargate Center Business Improvement District may be approved by the City Council by motion, resolution or ordinance.

Section 7. This ordinance shall be in full force and effect from and after its passage and publication as provided by the Charter.

Section 8. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.



## PETITION FOR APPOINTMENT OF NEW BOARD MEMBERS

IN RE THE ORGANIZATION OF THE BRIARGATE CENTER BUSINESS IMPROVEMENT DISTRICT, CITY OF COLORADO SPRINGS, COLORADO

COMES NOW, the Briargate Center Business Improvement District ("BID"), by and through its undersigned attorney and pursuant to Section 31-25-1209(1)(b), C.R.S., hereby petitions the Colorado Springs City Council ("City Council") to appoint five new members to the BID's Board of Directors.

## AS GROUNDS THEREFORE, Petitioner states as follows:

- 1. The BID was established by the City of Colorado Springs, Colorado, Ordinance No. 02-24, dated February 12, 2002, for the purpose of financing the public infrastructure needed to serve The Promenade Shops at Briargate located at 1885 Briargate Parkway, Colorado Springs, Colorado 80920 ("Lifestyle Center").
- 2. The BID is governed by a five-member Board of Directors ("Board") that is appointed by the City Council. To serve on the Board a person must be an elector of the BID as that term is defined in Section 31-25-1203(4)(a), C.R.S.
- 3. Pursuant to Section 31-25-1203 (4)(a) C.R.S., an elector is a natural person who is a citizen of the United States and a resident of the State of Colorado, who is 18 years of age or older and who:
  - I Makes his primary dwelling in the BID; or
  - II Owns taxable, real or personal property within the boundaries of the BID; or
  - III Is the holder of a leasehold interest in taxable real or personal property within the boundaries of the BID; or
  - IV Is a natural person designated by an owner or lessee of taxable real or personal property within the boundaries of the BID that is not a natural person, to vote for such owner or lessee in BID elections.
- 4. On or about August 13, 2019, the Lifestyle Center was sold by IMI, Colorado Springs, LLC, a Delaware Limited Liability Company ("IMI") to HGIT Briargate, LLC, a Delaware Limited Liability Company ("HGIT").

- 5. In connection with sale of the Lifestyle Center by IMI to HGIT, all five seats on the Board of Directors ("Board") of the BID became vacant because the then sitting Board members ceased to be electors of the BID.
- 6. Pursuant to Section 31-25-1209(1)(b) C.R.S., when a vacancy occurs on the Board, the vacancy is to be filled by the City Council.
- 7. Accordingly, the BID requests that the City Council appoint the following five individuals to the BID's Board of Directors: Chris Crawford, Jay Despard, Kate Owsald, Eric Weisenstein, and Madison Wilsmann.
- 8. Chris Crawford is the Managing Director, Head of Real Estate Acquisitions for Hines & Company. He joined Hines & Company in 2014 as a development associate and aided in project management and leasing of several developments in Denver's Central Business District. He is a Colorado native and graduated from Dartmouth College with a degree in government. Chris's address and telephone number are as follows:
