

ORDINANCE NO. 15-61

AN ORDINANCE AMENDING ORDINANCE NO. 14-101 (2015 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE GENERAL FUND IN THE AMOUNT OF \$213,188.77 FOR THE NOVEMBER 2015 ELECTION COSTS

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 14-101 is hereby amended by increasing the General Fund expenditure appropriation in the amount of \$213,188.77, which is the anticipated cost of the November 2015 election. The source of the General Fund monies is the General Fund available fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

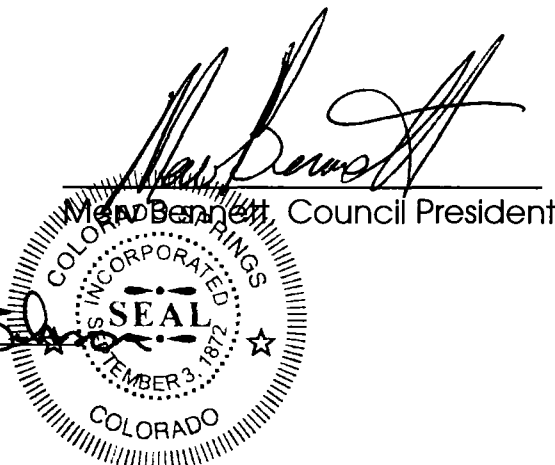


