WHEREAS, Jill has been a steadfast advocate for greater community connectivity, the urban tree canopy and propelling the City of Colorado Springs into the future. Her strong leadership, forward mobility and ability to effect change have made an irreplaceable mark on the City of Colorado Springs; and

WHEREAS, in light of this extraordinary public service, Jill has been a dedicated representative on behalf of the residents District 5, serving the interests and priorities of her community with distinction, determination and poise;
