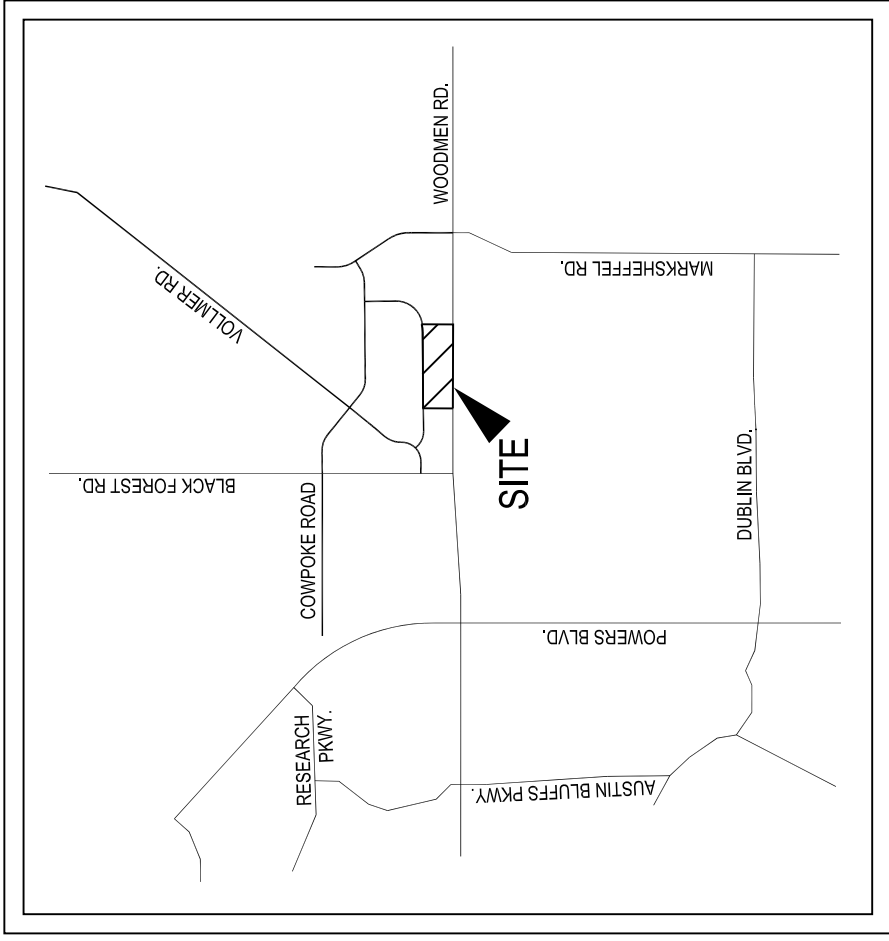


FOREST MEADOWS SOUTH CONCEPT PLAN

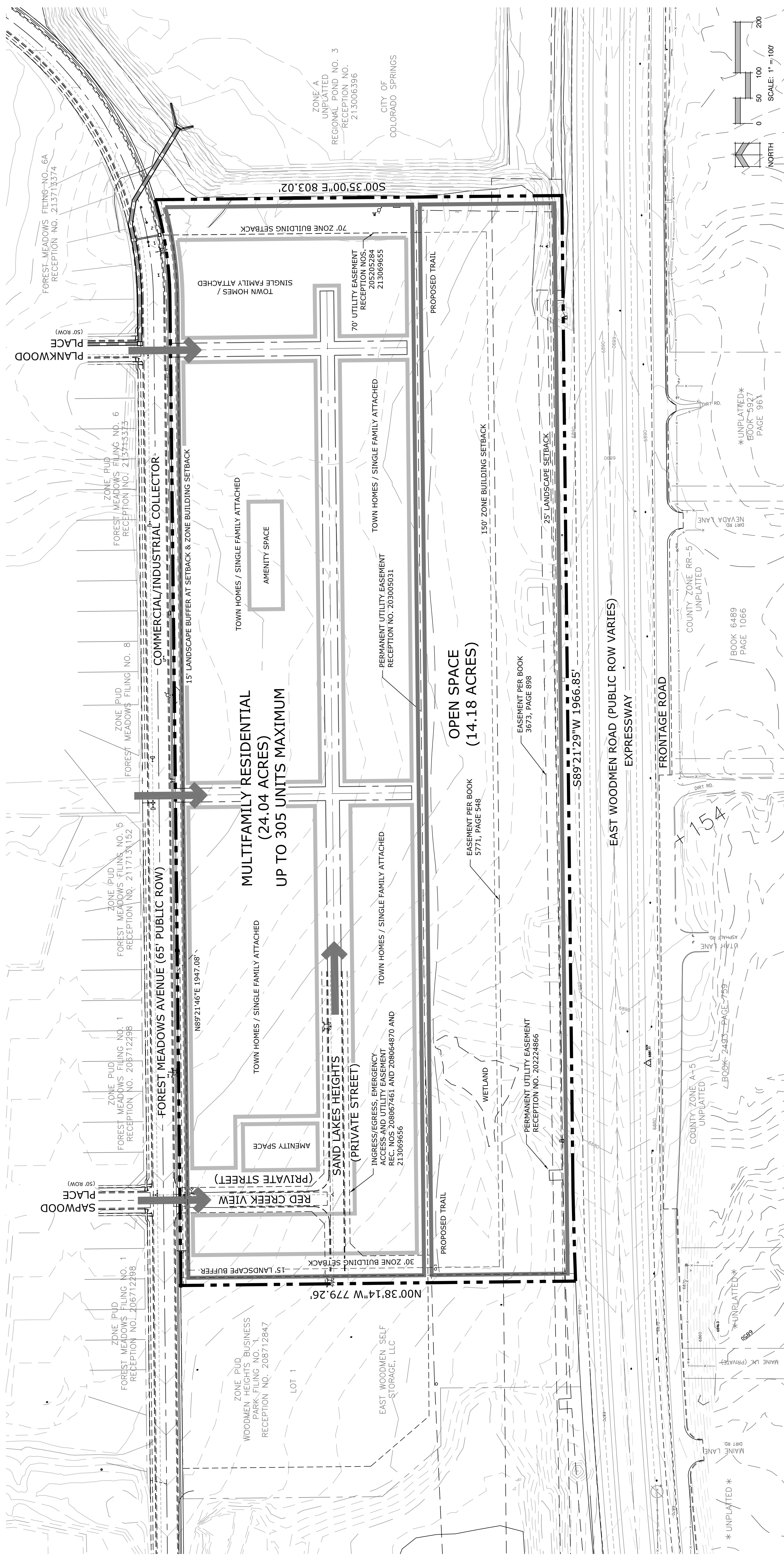
