# **Airport Advisory Commission**

Two vacancies occurred at the Airport Advisory Commission due to a resignation and an expired term. On September 4, 2025, Council Liaisons Kimberly Gold and Roland Rainey, along with Alexandru Kovacs, Aviation Director for Colorado Springs Airport, and John Buckley, Commission Chair, interviewed applicants. Dan Roehrs is recommended as a Voting member to fill one of the vacancies, having served as an Alternate since October 2023. John Buckley is also recommended to be reappointed for a second term on the Commission.

Special Improvement Districts (SIMD) are established under City Code (Chapter 19, Article 9) to provide ongoing maintenance, primarily for arterial street landscaping and entry features. Each SIMD is created by ordinance and governed by a citizen advisory board appointed by City Council. On September 3, 2025, Councilmember Tom Bailey reviewed applicants together with John Gebhart, SIMD Unit Administrator, and recommended qualified candidates.
