

ORDINANCE NO. 18-103

AN ORDINANCE VACATING PORTIONS OF A PUBLIC
RIGHT-OF-WAY KNOWN AS BANNING LEWIS RANCH
PARKWAY CONSISTING OF 14.645 ACRES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. City Council hereby finds, determines and declares that it is in the best interest of the City and its citizens to vacate and hereby vacates portions of a public right-of-way known as Banning Lewis Ranch Parkway consisting of 14.645 acres, as described in Exhibit A and depicted in Exhibit B, both of which are attached hereto and made a part hereof.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.

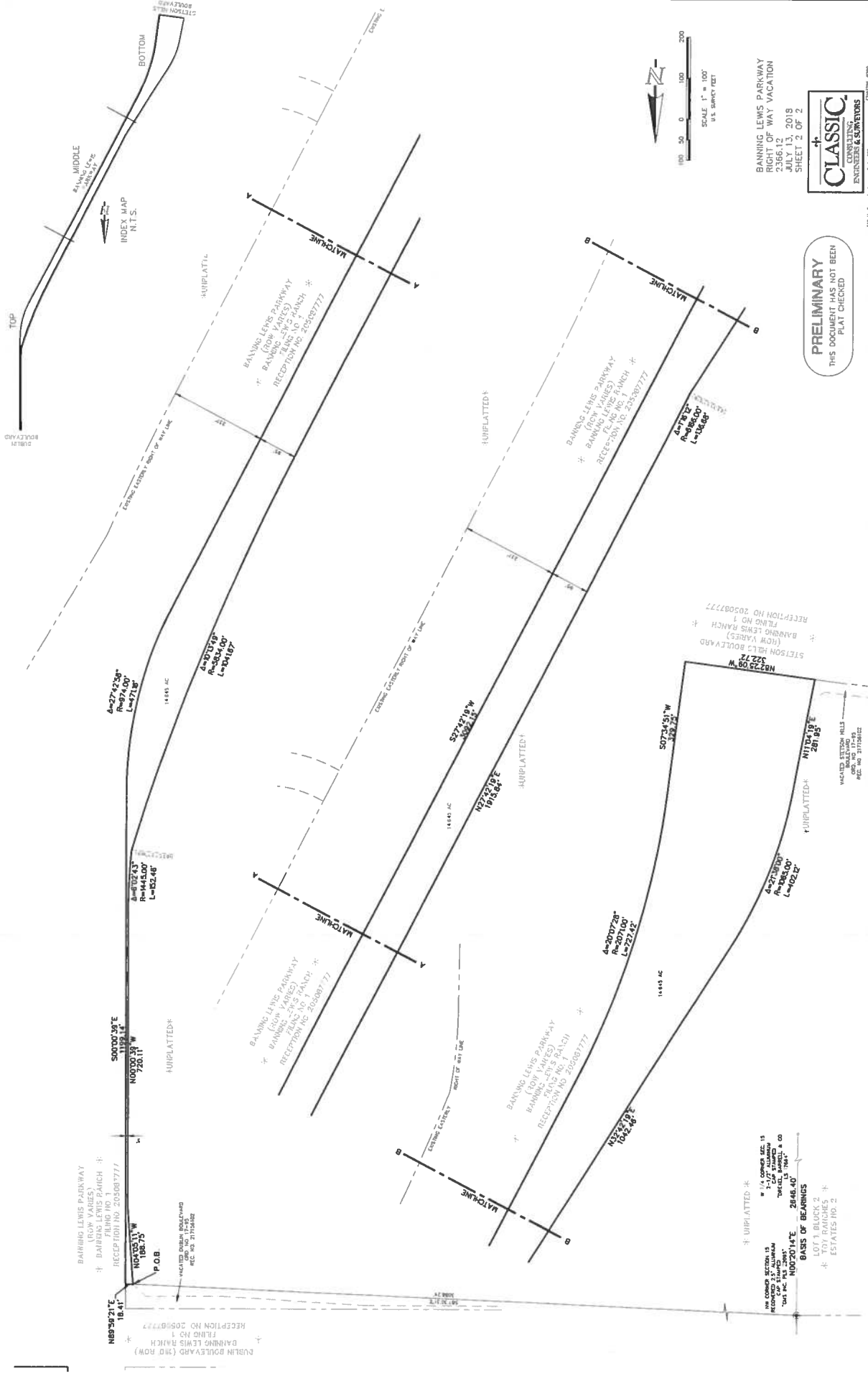
