

ORDINANCE NO. 18-92

AN ORDINANCE AMENDING ORDINANCE NO. 17-116 (2018 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$1,100,000 TO THE TRAILS, OPEN SPACE AND PARKS FUND FOR ACQUISITION OF UP TO 246 ACRES OF PROPERTY FOR THE PURPOSE OF PUBLIC OPEN SPACE AND TRAILS AS AN EXPANSION OF THE CORRAL BLUFFS OPEN SPACE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 17-116 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$1,100,000 inclusive of real estate transaction costs including fencing as necessary to secure the property, for acquisition of up to 246 acres of property from Larry L. Bishop and Lorretta L. Branham, co-personal representatives of the Estate of Everett S. Bishop for the purpose of public open space and trails as an expansion of the Corral Bluffs Open Space. The source of funds is the Trails, Open Space and Parks Fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.

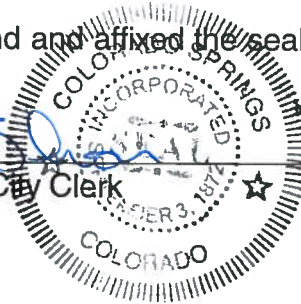
