Thank you for your follow up to the sign enforcement notification. The document that you forwarded is the city's regulations on banners however like our discussion on the phone you are within a center and boundaries that have two Electronic Message Center Signs which prohibit temporary signs within the property (banners, Inflatable displays ect.) See attached.

My recommendation would be to utilize the window allocation on all three elevations of your building until you are able to get permanent signage installed which will also require permitting.

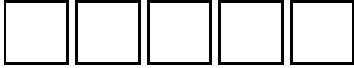
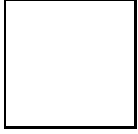
