

ORDINANCE NO. 14-107

AN ORDINANCE AMENDING ORDINANCE NO. 13-77  
(2014 APPROPRIATION ORDINANCE) FOR A  
SUPPLEMENTAL APPROPRIATION TO THE GENERAL  
FUND IN THE AMOUNT OF \$500,000 FOR THE PURPOSE  
OF DRAINAGE REPAIRS ON POWERS BOULEVARD

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
COLORADO SPRINGS:

Section 1. Ordinance No. 13-77 is amended by increasing the Public  
Works Department's expenditure appropriations of the General Fund in the  
amount of \$500,000 for the purpose of drainage repairs on Powers Boulevard.  
The source of funds is the General Fund unrestricted fund balance.

Section 2. This ordinance shall be in full force and effect from and after  
its final adoption and publication as provided by charter.

Section 3. Council deems it appropriate that this ordinance be published  
by title and summary prepared by the City Clerk and that this ordinance shall be  
available for inspection and acquisition in the office of the City Clerk.
