

ORDINANCE NO. 16-32

AN ORDINANCE RENAMING ARTICLE 2 (AMUSEMENTS) AND MOVING UNDER THE RENAMED ARTICLE 2 (MARIJUANA) PART 1 (MEDICAL MARIJUANA LICENSE CODE) AND ALL SUBSEQUENT SECTIONS (101-109) OF ARTICLE 3 (SALES OF GOODS AND SERVICES) OF CHAPTER 2 (BUSINESS LICENSING, LIQUOR REGULATION AND TAXATION) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO MARIJUANA

WHEREAS, the City's Medical Marijuana License Code is currently codified in Part 1 (Medical Marijuana License Code) of Article 3 (Sales of Goods and Services) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation) of the City Code; and

WHEREAS, Council intends to adopt new business license requirements and regulations for marijuana consumption clubs; and

WHEREAS, Council deems its best interest for clarity is to keep all subject matter together within the City Code; and

WHEREAS, Council has concluded that the recently repealed Article 2 (Amusements) is an appropriate place within the City Code to consolidate the City's marijuana-related business license requirements and regulations; and

WHEREAS, Council intends that all current requirements and regulations established by Ordinance Nos. 11-32 and 13-47 in Sections 101-109 under Part 1 (Medical Marijuana License Code) of Article 3 (Sales of Goods and Services) shall remain in full force and effect as originally adopted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Article 2 (Amusements) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation) of the Code of the City of Colorado Springs 2001, as amended, shall be renamed Article 2 (Marijuana) and all current Parts (1-4) under Article 2 are deleted.

Section 2. Part 1 (Medical Marijuana License Code) and all its subsequent sections (101-109) of Article 3 (Sales of Goods and Services) is moved under a newly created Part 1 (Medical Marijuana License Code) of Article 2 (Marijuana) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation) of the Code of the City of Colorado Springs 2001, as amended.


Section 3. Part 1 of Article 3 (Sales of Goods and Services) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation) of the Code of the City of Colorado Springs 2001, as amended, is reserved.

Section 4. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 5. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.




