

ORDINANCE NO. 21-34

AN ORDINANCE AMENDING ORDINANCE NO. 20-92 (2021 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE TRAILS, OPEN SPACE AND PARKS (TOPS) FUND IN THE AMOUNT OF \$2,797,113 FOR THE PHASE II ACQUISITION OF APPROXIMATELY 61 ACRES OF PROPERTY KNOWN AS THE PIKEVIEW FRONTAGE PROPERTY OWNED BY THE CONSERVATION FUND FOR THE PURPOSE OF PUBLIC OPEN SPACE AND TRAILS IN THE MOUNTAIN SHADOWS CANDIDATE OPEN SPACE AREA

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 20-92 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$2,797,113 inclusive of the purchase price, professional services fee, and interest for acquisition of the remaining approximately 61 acres of property located at the frontage area of the Pikeview Quarry for the purpose of public open space and trails. The source of funds for the land acquisition is the TOPS available fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.


