6. Citizen Discussion

Citizen Gerald Miller spoke about the crime in his neighborhood and about violence against Police Officers.

Citizen Carl Strow spoke regarding the improvements that need to be made on the Barr Trail and the Manitou Incline.

Citizen Les Wood stated that he was thankful to be part of the community.

Citizens John Hawk, Ester Mueller, and David Gardner spoke in opposition of the proposed amendment to the annexation agreement and development of Banning Lewis Ranch.

Citizen Kevin Bright suggested combining the techniques of marijuana growers with urban farming.

Citizens Pat Doyle, member of the Old North End Neighborhood Board, and Bob Loevy expressed appreciation and support for the approved transportation and pedestrian safety plan for the neighborhood.

Citizen Becky Fuller spoke in opposition of the approved transportation and pedestrian safety plan for the Old North End Neighborhood and the lack of public involvement. President Pro Tem Gaebler commented that there were three large public process meetings regarding the plan.

Councilmember Pico asked why City Council was not previously able to review the Old North End transportation and pedestrian safety plan. Jeff Greene, Chief of Staff, said the recommendation for the plan was initiated by the City's traffic engineer, not Colorado College. Councilmember Murray stated that he had not received the safety data. Mr. Greene stated that this does not relate to the Colorado College master plan changes, it is related to a traffic and engineering determination for public safety.

Councilmember Knight stated that any changes to this street should have gone through the Planning Department and then City Council. Mr. Greene stated that it is the goal of the Mayor's office to collaborate with the legislative branch.

Citizens Marsha Wicke and Tom Noonan spoke against the proposed fare increase for Metro Mobility passengers on the fixed-route bus service.

Walter Lawson spoke regarding the need for transparency regarding the economic development analysis for the revenue impact of Colorado Springs Utilities as a result of the proposed development of Banning Lewis Ranch (BLR). Councilmember Knight stated that the budget committees are reviewing the accuracy of the data. Councilmember Strand stated that some of the information regarding Colorado Springs Utilities is proprietary. Brian Whitehead, Colorado Springs Utilities, stated there are projections for a net positive increase in revenue with the proposed additional development of Banning Lewis Ranch. He explained that because Colorado Springs Utilities is a non-profit organization, there would not be profit, but it would be a benefit to the rate payers as adjustments. Bethany Burgess from the Attorney's Office, Colorado Springs Utilities Division, stated that some of the information that has been discussed is confidential at this time because of settlement negotiations that are under pending litigation, but as things are finalized, it will be made public. Councilmember Murray requested the projection of surplus revenue to the City based on the development of BLR. Councilmember Pico stated that if there is a revenue surplus associated with BLR, it will go into capital infrastructure, be paid toward the debt, or there will be a reduction in rates.

Citizens Tom Gonzales and Marla Luckey from El Paso County Health spoke regarding the dangers of radon and presented a public service announcement video.

Citizen Deborah Stout-Meiningner spoke against the approval of additional developments within the City.

Citizen Ryan Jones spoke regarding increasing enforcement against homeless camps.

Citizen Susan Davies, Trails and Open Space Coalition spoke for the Bike Colorado Springs initiative.

Citizen Jaymen Johnson spoke regarding alleged government impropriety.

Citizens Andrew and Sandra Knauff spoke regarding an accessory dwelling unit (ADU) that was built in their neighborhood that they believe to be against City Fire Code.

Peter Wysocki, Director Planning and Community Development, gave a brief history of the Renew North Nevada Avenue Master Plan.

Nina Vetter, Innovation and Sustainability Project Manager, presented the project area map of the Renew North Nevada Avenue Master Plan, the project vision of how citizens of the community move, live, work, and how the corridor is landscaped. She identified the community participation and timeline goals. Ms. Vetter described the community recommendations and the zoning overlay objectives. She explained the land uses that will be allowed in the new master plan and those that are prohibited as well as the key aspects of the zoning overlay design guidelines.

Ted Ritschard, Kimley Horn, presented the Renew North Nevada Avenue transportation sub-plan which outlined the strategies and recommendations needed to ensure the transportation goals of the Renew North Nevada Avenue Master Plan. He identified the proposed intersection improvements for North Nevada Avenue and Cascade Avenue.

Ms. Vetter stated that they have received unanimous approvals from all the boards and commissions that they presented to.

Councilmember Knight suggested an amendment to the motion regarding the permission of human service establishments in certain zoning areas as required by the City Code.

Councilmember Geislinger commented that even though he supports this plan, the City needs to be prepared to deal with the impact to the people in that area that will be displaced.

Marc Smith, Division Chief, Corporate Legislative Counsel, stated the City

Attorney's Office accepts the amendment to the motion and that the only sub-category that was an issue was the sub-category of human service home.

Citizen Tom Noonan commented that he would like to see Transit Services involved in the planning and said the distance from the bus lane to the businesses should be minimal.

Roger Lovell, Building Official, Regional Building Department, presented the executive summary of the proposed revisions to the currently adopted 2011 Pikes Peak Regional Building Code (PPRBC) and identified the

codes that would be adopted with the 2017 edition. He also explained the change in wind speed requirements for structural designs and said the most extensive change to the PPRBC is the energy conservation code.

Councilmember Geislinger asked if these changes were consistent with other Front Range jurisdictions. Mr. Lovell confirmed they were as well as with the rest of the state of Colorado and the United States.

Jim Riggins, former independent energy code inspector for the PPRBD and member of the building committee for Pikes Peak Habitat for Humanity, expressed his appreciation for the concerns regarding the impact of the new modern energy conservation code as it relates to low income families and affordable housing. He stated it will lower the total cost of ownership through energy savings.

Councilmember Strand asked what the initial energy cost to home buyers would be. Mr. Riggins said the average initial cost increase was \$827 for a 1,200 square foot apartment if a builder used the prescriptive path, but that builders could follow a performance path which would make it more affordable.

Councilmember Pico asked what the initial energy cost increase would be for an average size house. Mr. Riggins said the cost increase range is between \$827-\$1,715.

Mr. Lovell commented that a number of other jurisdictions have already adopted the 2015 PPRBC without any amendments.

Lori Rhodes with Challenger Homes stated that the new codes will increase the cost of a new home by approximately \$3,000-\$4,500.
