

ORDINANCE NO. 26 - 13

AN ORDINANCE REPEALING ORDINANCE NOS. 02-10
AND 21-92 THEREBY DISSOLVING THE CITIZENS'
TRANSPORTATION ADVISORY BOARD

WHEREAS, City Council created the Citizens' Transportation Advisory Board with the passage of Ordinance 02-101 on June 25, 2002 to advise City Council and City Manager on matters relating to the City's multi-modal transportation system; and

WHEREAS, City Council further refined the membership of the Board through Ordinance 21-92 adopted on November 9, 2021, which expanded Board Member roles to those who represent individuals who ride bicycles, walk, transit, and have a disability that impacts their means of transportation; and

WHEREAS, City Council expresses its sincere gratitude to the members of the Citizens' Transportation Board for their dedicated service and contributions to the community that include review and prioritization of Pikes Peak Rural Transportation Authority projects in 2004, 2012, and 2022, work related to truck routes, and review of ConnectCOS; and

WHEREAS, after a thorough review and stakeholder engagement process, City Council has determined changes in governance and expanded resident transportation engagement channels have created overlaps in responsibilities initially held solely by the Board; and

WHEREAS, City Council has determined the Citizens' Transportation Advisory Board no longer serves a legislative function.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY
OF COLORADO SPRINGS:

Section 1. Ordinance Nos. 02-10 and 21-92 are repealed. The Citizens' Transportation Advisory Board is hereby dissolved.

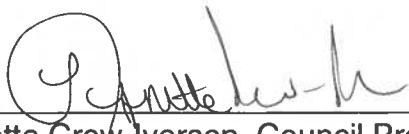
Section 2. This Ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

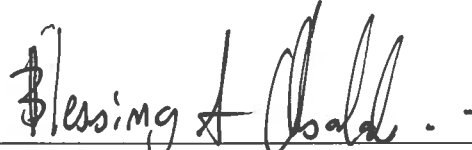
