

ORDINANCE NO. 17-49

AN ORDINANCE AMENDING SECTION 104 (DEPOSIT OF COINS OR TOKENS; TIME LIMITS; PROHIBITIONS) AND SECTION 106 (PERMITS FOR EXTENDED USE OF PARKING METERS) OF ARTICLE 15 (PARKING METER REGULATIONS) OF CHAPTER 10 (MOTOR VEHICLES AND TRAFFIC) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO PARKING METER REGULATIONS

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 104 (Deposit of Coins or Tokens; Time Limits; Prohibitions) of Article 15 (Parking Meter Regulations) of Chapter 10 (Motor Vehicles and Traffic) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

10.15.104: DEPOSIT OF COINS OR TOKENS; TIME LIMITS; PROHIBITIONS:

* * *

F. It shall be unlawful for any person, vendor or peddler to sell, offer for sale, solicit or serve goods, services, wares or foodstuffs from any metered parking space **without a permit** regardless of the hours of meter operation or enforcement.

Section 2. Section 106 (Permits for Extended Use of Parking Meters) of Article 15 (Parking Meter Regulations) of Chapter 10 (Motor Vehicles and Traffic) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

10.15.106: PERMITS FOR EXTENDED USE OF PARKING METERS:

The Parking Manager is authorized to issue permits for the extended use of parking meters, upon payment of reasonable fees as the Manager may recommend and City Council may from time to time establish, to allow the reservation of specified metered parking spaces for the use of: a) specified vehicles engaged in repair work, remodeling or new construction, or the furnishing of tools and equipment in the immediate vicinity of the meter or meters to be reserved; b) special events; c) dumpsters, roll-offs, PODs or similar types of containers; ~~or~~ d) valet services; **or e) mobile food vendors.** Each permit shall be placed in a specifically designed hood to be placed over the head of the reserved meter. No permittee or other person shall violate any of the terms of any permit.


Section 3. Any person convicted of violating Section 104 (Deposit of Coins or Tokens; Time Limits; Prohibitions) of Article 15 (Parking Meter Regulations) of Chapter 10 (Motor Vehicles and Traffic) shall be punished as provided in Section 101 (Penalties) of Part 1 (General Provisions) of Article 1 (Administration and Enforcement) of Chapter 10 (Motor Vehicles and Traffic) and Section 104 (Right to Trial by Jury; Jail; Exceptions) of Article 4 (Jury Provisions) of Chapter 11 (Municipal Court) of the Code of the City of Colorado Springs 2001, as amended.

Section 4. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 5. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
