

ORDINANCE NO. 20-81

AN ORDINANCE AMENDING ORDINANCE NO. 19-87 (2020 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE GRANT FUND IN THE AMOUNT OF \$67,013,392, THE AIRPORT GRANT FUND IN THE AMOUNT OF \$24,340,290, AND THE CDBG GRANT FUND IN THE AMOUNT OF \$1,811,610 FOR THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES) GRANTS FUNDING RESPONSE TO AND RECOVERY FROM THE CORONAVIRUS PANDEMIC

WHEREAS, on March 13, 2020, the President declared the ongoing Coronavirus Disease 2019 (COVID-19) pandemic of sufficient severity and magnitude to warrant an emergency declaration for all states, tribes, territories, and the District of Columbia pursuant to section 501 (b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207 (the "Stafford Act"), and

WHEREAS, in response to the economic impact of responding to the COVID-19 pandemic, legislation was approved by Congress and signed into law by President trump on March 27, 2020. This legislation is the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) and authorizes more than \$2 trillion to address COVID-19 and its economic effects, and

WHEREAS, as part of the CARES Act, many federal agencies received allocations, providing grants to states and local governments for purposes specific to their organizations, and

WHEREAS, the City of Colorado Springs received CARES Act funding through the Federal Aviation Administration, Federal Transit Administration, U.S. Department of Justice, U.S. Housing and Urban Development, U.S. Department of Treasury, passed through from the direct allocation to El Paso County, and the Federal Emergency Management Agency, for purposes of responding to and recovering from the COVID-19 pandemic.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 19-87 is hereby amended by increasing the Grant Fund revenue and expenditure appropriation in the amount of

\$67,013,392 in order to fund eligible response and recovery activities related to the coronavirus pandemic, to include, but not limited to economic support and business interruption support as necessary through separate grant programs, or through existing programs or contracts, including those identified in Resolution 39-20, which have been reduced due to the impacts of the coronavirus pandemic, personal protective equipment, technology, and facility modifications to assist with social distancing measures, as defined by the Federal Emergency Management Agency, U.S. Department of the Treasury, Federal Transit Administration, the U.S. Department of Housing and Urban Development, and the U.S. Department of Justice. The source of funds is revenue from the Federal Emergency Management Agency (FEMA) through the Colorado Department of Public Safety (\$1,275,000), the U.S. Department of the Treasury through El Paso County (\$37,526,357), the Federal Transit Administration (\$21,562,532), the U.S. Department of Housing and Urban Development, Emergency Solutions Grant-CV program (\$5,984,403), and the U.S. Department of Justice (\$665,100).

Section 2. That Ordinance No. 19-87 is hereby amended by increasing the Airport Grant Fund revenue and expenditure appropriation in the amount of \$24,340,290 in order to fund eligible response and recovery activities at the Colorado Springs Airport related to the coronavirus pandemic, as defined by the Federal Aviation Administration. The source of funds is revenue of \$24,340,290 from the Federal Aviation Administration.

Section 3. That Ordinance No. 19-87 is hereby amended by increasing the CDBG Grant Fund revenue and expenditure appropriation in the amount of \$1,811,610 in order to fund eligible response and recovery activities related to the coronavirus pandemic, as defined by the U.S. Housing and Urban Development's U.S. Department of Housing and Urban Development, Community Development Block Grant-CV program. The source of funds is revenue of \$1,811,610 from the U.S. Department of Housing and Urban Development.

Section 4. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 5. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.






