Councilmember Donelson stated this Ordinance was drafted to address the illicit massage parlors in town and went over the amendments which had been made based on the input of stakeholders.

Commander Scott Whittington identified the details of the inspection process and the need for probable cause.

Citizens CJ Brazee, Rebecca Lambert, Shelly Cox, Derek Enslow, Brandy

Beisser, Jaymen Johnson, and Kim Randall, spoke in opposition to the proposed Ordinance.

Councilmember Fortune recognized massage therapists as healthcare workers and stated there needs to be a solution to the problem.

Councilmember Williams stated City Council is willing to revisit this Ordinance if there are unintended consequences.

Councilmember Henjum asked how this Ordinance will assist in enforcing illegitimate massage parlors. Commander Whittington stated there is nothing in state law which allows CSPD to take action against illicit massage parlors based on state massage therapist certification and this Ordinance will allow enforcement of in a much more efficient way.

Councilmember Henjum requested this Ordinance be revisited by City Council in approximately six months or when appropriate.

Councilmember Henjum stated she pulled this item due to her and Councilmember Avila's discussion with two Colorado College students regarding the City's affordable housing projects.

Katie Sunderlin, Senior Affordable Housing Coordinator, presented the Ordinance authorizing the issuance and delivery of its Multifamily Housing Revenue Note Series 2022, in an aggregate amount not to exceed \$24,000,000, for the purpose of financing the acquisition, construction, improvement and equipping of an affordable multi-family rental housing facility ((Copper Rose Apartments Project) of 182 units. She stated the maximum rent for a two-bedroom unit is \$1,210 and these units are renting to households with sixty percent Average Median Income (AMI). Ms. Sunderlin provided an overview of the site location, project proposal, alignment with HomeCOS, and available private activity bonds (PAB).

President Strand requested additional information regarding PAB. Ms. Sunderlin stated PAB is issued by the state and is based on population and most of it is used for affordable housing.
