

ORDINANCE NO. 25 - 94

AN ORDINANCE AMENDING SECTION 106 (FAILURE TO PAY FINE) OF ARTICLE 3 (PROCEDURES) OF CHAPTER 11 (MUNICIPAL COURT) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO FAILURE TO PAY FINES, COSTS, OR SURCHARGES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 106 (Failure to Pay Fine) of Article 3 (Procedures) of Chapter 11 (Municipal Court) of The Code of The City Of Colorado Springs 2001, as amended, is amended to read as follows:

11.3.106: FAILURE TO PAY FINES, COSTS, OR SURCHARGES:


Whenever ~~a fines, costs, or surcharges~~ **is are** imposed for a municipal ordinance or Code ~~offense-violation~~, if the defendant **fails to pay or** is unable to pay the **finest, costs, or surcharges** imposed ~~or if the defendant fails to pay the fine~~, the Municipal Judge ~~may~~ **must** proceed in accord with ~~Colorado Revised Statutes~~ **C.R.S. section** § 18-1.3-702.

Section 2. This Ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this Ordinance be published by title and summary prepared by the City Clerk and that this Ordinance be available for inspection and acquisition in the office of the City Clerk.




