

ORDINANCE NO. 18-120

AN ORDINANCE APPOINTING THE CITY COUNCIL
ADMINISTRATOR AND SETTING THE SALARY OF THE
CITY COUNCIL ADMINISTRATOR

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. In accordance with City Charter § 3-10(e), the Council appoints, by the concurring vote of a majority of its members, Emily Evans as City Council Administrator.

Section 2. Emily Evans shall fulfill the duties and responsibilities of the City Council Administrator as set forth in City Code Ch. 1, Art. 2, Part 10, and other applicable laws, rules or regulations.

Section 3. In compliance with City Charter § 3-10(e), City Council Administrator Emily Evans' annual salary, beginning the effective date of appointment and thereafter until and unless amended by Council, shall be set at \$98,614, annually, together with all applicable benefits.

Section 4. The effective date of Emily Evans' appointment as City Council Administrator shall be November 28, 2018.

Section 5. This ordinance supersedes all prior ordinances that are inconsistent herewith to the extent such prescribed the salary of the City Council Administrator.

Section 6. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by City Charter.


