A RESOLUTION SETTING THE FEES FOR THE GENERAL  
BUSINESS LICENSES ISSUED BY THE CITY CLERK'S  
OFFICE

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY  
OF COLORADO SPRINGS:**

Section 1. That the fees and charges as set forth on the attached Exhibit "A" are hereby established for the business licenses.

Section 2: That the fees and charges are effective January 1, 2019 and shall remain effective until changed by subsequent resolution by City Council.

Section 3: That future amendments to the fee schedule are subject to subsequent review and adoption by City Council.

Section 4. Except for any and all resolutions and ordinances setting fees for medical marijuana business licenses under Part 1 (Medical Marijuana License Code) of Article 3 (Sales of Goods and Services) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation), this resolution shall supersede and rescind any and all prior resolutions and ordinances setting any amount of fee for any license subject to the General Licensing Code of the City of Colorado Springs.
