ORDINANCE NO. 79-16

AN ORDINANCE VACATING A PORTION OF PRINCETON AVENUE BETWEEN NORTH 34TH

STREET AND RIDGE ROAD

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The City Council hereby finds, determines and declares that it is to the best interests of the City and its citizens to vacate that portion of Princeton Avenue between North 34th Street and Ridge Road (platted as Priscilla Lane) described in Exhibit A, attached hereto and by reference made a part hereof, and accordingly that the same be and hereby is vacated, reserving, however, to the City the right to construct, maintain and operate drainage facilities and utilities, including without restriction or limitation, overhead lines, wires, supporting structures, poles, pipes, mains, manholes, ditches, flumes, and all accessories thereto, together with a full right of ingress and egress by the City over and across the above described property for purposes of construction, operation and maintenance of said facilities and utilities and all appurtenances thereto.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by the Charter.
