BEGINNING AT A NUMBER 4 REBAR WITH 1" YELLOW PLASTIC CAP, PLS \*6218, BEING THE SOUTHEASTERLY CORNER OF SUBJECT PARCEL, ALSO BEING THE SOUTHWEST CONER OF LOT 1, MT. WASHINGTON INDUSTRIAL PARK FILING NO. 1; THENCE NORTH 64°35'02" WEST ALONG THE FORMER NORTHERLY RIGHT-OF-WAY LINE OF THE ATCHISON, TOPEKA AND SANTA FE RAILROAD, A DISTANCE OF 916.66 FEET TO A NUMBER 5 REBAR WITH 1-1/4" ORANGE PLASTIC CAP, PLS 32439, ALSO BEING THE SOUTHWEST CORNER OF SAID LOT 22, MT. WASHINGTON INDUSTRIAL PARK FILING NO. 2; THENCE SOUTH 00°34'54" EAST ALONG THE WEST LINE OF SAID LOT 3, A DISTANCE OF 265.55 FEET TO THE SOUTHWEST CORNER THEREOF, ALSO BEING A POINT ALONG THE NORTH LINE OF LOT 1, MT.
