in my research I found the following...
AI statement: Battery Storage Facilities are prone to various faults that can lead to fires and explosions. The most and notable are Germany, home explosions using this energy for sustainability in their home. This occurred in 2 cases, in Poland a massive E Bike fire in a storage facility. Closer to home as part of the green energy project in New York there were 3 plant fires + explosions. Even closer to home ⁱⁿ Ohio, OH, MassDartmouth near Monterey, CA, Elkhorn Slough, and Fredericktown, MO. These fires were linked to Thermal Runaway, defect in battery chemistry, overheating, poor air conditioning, and incorrect design parameters, and short circuit caused by defects. Again, causing fire + explosions, in a comment from STACHEB "Warning: product this should be considered a 'Warning'. Causes as briefly mentioned thus far are Thermal Runaway a rapid, uncontrolled heat generation within a cell + for cells. Defects in a cell or the cells damaged when installed, and improper operation. Electrical issues overcharging, over discharge, short circuit.

Environmental factors of temperature, humidity, condition outside recommended ranges effects performance. In our case snow and tornadoes. (Steel jacket tornadoes).

Root investigation and assembly connection fault. Improper installation incorrect wiring, circuit overload, insufficient ventilation.

lack of maintenance making of potential issues increasing the risk of failure.

Off gassing is a release of toxic + flammable gases from the batteries it becomes a safety risk and/or fire hazard.

In my research it was noted that

the safety protocol in California was presented as high, however in 4 years there have been 4 major fires/explosions. Endangering human and animal life, ecosystem, livestock, and displaced many as the environment was toxic. These fires and or explosions are fueled by water. Think about it, water in Colorado?
